
A motion was made by Commissioner Mossman and seconded by Commissioner Risley that the meeting be adjourned. Upon a roll call being taken, the results were as follows:

**MINUTES OF CLOSE-OUT/GRANT PERFORMANCE PUBLIC HEARING
Monday, September 10, 2018, 6:45 pm**

The City of Sullivan Mayor, Ann Short, called the close-out and grant performance public hearing concerning the Community Development Block Grant Program (CDBG) Public Facilities grant to order. She then introduced the project representative for the proposed project. The mechanics of the substantially completed Public Facilities project as follows:

The City used CDBG Public Facilities grant funds to serve targeted residents the City of Sullivan (Moultrie County). The City's target area has a high concentration of low-to-moderate income families and there was a health and safety threat to these residents because of unsafe sanitary sewer system. The CDBG grant is funded by the Federal Government and administered by the State.

The City of Sullivan was awarded a \$450,000 grant from the CDBG fund. To match this, the City approved a total of \$218,769.25 of leverage funds, toward this project. The Public Facilities improvements project costs totaled approximately \$668,769.25 which included: sanitary sewer system improvements, construction engineering, grant activity delivery and all related costs.

According to an area household survey conducted in 2011, 70% of the target area residents surveyed are considered low-to-moderate income. There was no displacement of occupied households as a result of the proposed activities.

The current sanitary sewer system in this target area of the City of Sullivan was unsafe. The Public Facilities grant funds lead to the construction of sanitary sewer system improvements which, in turn, alleviated health and safety threats as mentioned.

The floor was opened for questions and comments from the audience.


**QUESTION
