ORDINANCE AMENDING CHAPTER 24 – MOTOR VEHICLE CODE, ARTICLE VI – PARKING RULES, SECTION 26-6-4 STOPPING, STANDING OR PARKING PROHIBITED IN SPECIFIED PLACES, SCHEDULE “F” – LIMITED OR SPECIAL PARKING ZONES OF THE REVISED CODE OF ORDINANCES OF THE CITY OF SULLIVAN, ILLINOIS

NOW BE IT ORDAINED by the City Council of the City of Sullivan, Moultrie County, Illinois, as follows:

Section 1: Section 24-6-4 – STOPPING, STANDING OR PARKING PROHIBITED IN SPECIFIED PLACES, SCHEDULE “F” LIMITED OR SPECIAL PARKING ZONES shall be amended to include the following:

VIII. **School Visitor Parking.** Between the hours of 8:00 a.m. to 3:00 p.m., there shall be Visitor Parking Only, with No Parking Students or Staff Between Signs, on the west side of Main Street from Magill Street on the south to the north entrance of the high school parking lot on the north (650 feet north of Magill Street).

IV. **School No Parking.** Between the hours of 7:30 a.m. and 3:30 p.m. when school is in session, there shall be No Parking on the east side of Main Street from Magill Street on the south to the north entrance of the high school parking lot on the north (650 feet north of Magill Street).

Section 2: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

Section 3: This ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law.

Section 4: This ordinance shall be known as Ordinance No. 18-17.
