**ORDINANCE NO. 19-13**  
**ORDINANCE AMENDING SCHEDULE "H", HANDICAPPED PARKING ZONES TO**  
**SECTION 24-6-5 (E) OF THE REVISED CODE OF ORDINANCES OF THE CITY OF**  
**SULLIVAN, ILLINOIS**

BE IT ORDAINED BY THE Mayor and City Council of the City of Sullivan, Moultrie County, Illinois, that:

SECTION 1: There shall be an amendment to Section "H", Handicapped Parking Zones, increasing the number of designated spaces for S. Madison St, on the west side of the street between E. Harrison and E. Jefferson, (back entrance to senior citizens building) to two (2) handicapped spaces.

SECTION 2: There shall be an amendment to Section "H", Handicapped Parking Zones, removing the designated spaces for W. Jefferson St. on the NW corner of W. Jefferson and S. Main, (north side of street across from Lane Systems) and removing the designated spaces for N. Washington on the east side of street between E. Jackson and E. Monroe (Chevrolet garage)

SECTION 3: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 4: This ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.

SECTION 5: This ordinance shall be known as Ordinance 19-13.
