**ORDINANCE NO. 19-15**  
**ORDINANCE AMENDING SCHEDULE "H", HANDICAPPED PARKING ZONES TO**  
**SECTION 24-6-5 (E) OF THE REVISED CODE OF ORDINANCES OF THE CITY OF**  
**SULLIVAN, ILLINOIS**

BE IT ORDAINED BY THE City Council of the City of Sullivan, Moultrie County, Illinois, that:

SECTION 1 There shall be an amendment to Section "H", Handicapped Parking Zones, creating one designated space on the West end of the SE corner of S Washington St. and W Jefferson St. (in front of The Makers Mercantile), and reinstating the designated space for W Jefferson St. on the NW corner of W Jefferson and S Main (located South of China King)

SECTION 2 All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 3 This ordinance shall be in full force and effect from and after its passage, approval and publication as required by law

SECTION 4 This ordinance shall be known as Ordinance 19-15
