**ORDINANCE NO. 19-6**  
**ORDINANCE APPOINTING REPRESENTATIVE TO THE ILLINOIS PUBLIC**  
**ENERGY AGENCY BOARD OF DIRECTORS**

WHEREAS, the City of Sullivan is a Member of the Illinois Public Energy Agency;  
and

WHEREAS, each Member of the Agency is entitled to a representative on the Board of Directors of the Illinois Public Energy Agency, which representative is to be appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the Mayor has appointed Richard Glazebrook, who is Mayor of Sullivan, IL to be the City's representative on the Illinois Public Energy Agency Board of Directors.

BE IT HEREBY ORDAINED by the City Council of the City of Sullivan, Moultrie County, Illinois that the appointment by the Mayor of Richard Glazebrook to be the City's representative on the Illinois Public Energy Agency Board of Directors is hereby confirmed, said appointment to be effective May 13, 2019 for the remainder of the current term of said representative and thereafter until his successor is duly appointed, confirmed and seated.

BE IT FURTHER ORDAINED that said representative shall have full power and authority to vote as the representative of the City of Sullivan in conjunction with all Illinois Public Energy Agency matters.
