ORDINANCE AMENDING CHAPTER 9 – CEMETERY SECTIONS 9-1-1 (E) AND 9-1-2,
OF THE REVISED CODE OF ORDINANCES OF THE CITY OF SULLIVAN, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Sullivan, Moultrie County, Illinois that:

SECTION 1 CHAPTER 9 – CEMETERY, ARTICLE I – BOARD ESTABLISHED, SECTION 9-1-1(E) shall be amended to read as follows

(E) The Board of Mangers shall meet at least one time per year and organize in accordance with the state statutes They shall operate in accordance with the statute and any revisions thereof, and all applicable ordinances of the City (**See 65 ILCS Sec. 5/11-52.1-2**)

SECTION 2 CHAPTER 9 – CEMETERY, ARTICLE I – OATH, QUORUM, PLACE OF MEETING, TIME, ETC Section 9-1-2 shall be amended to read as follows

9-1-2 QUORUM, PLACE OF MEETING, TIME, ETC. A majority of the members of the Board shall constitute a quorum for the transaction of business, and they may hold general or special meetings at the City Council rooms or other place as may be designated by the Board of Managers, at such times as they may by order direct, and they may make and establish such reasonable by-laws, rules and regulations as may be necessary for their own government, and for the full and complete execution of their powers and duties, and submit a copy thereof to the City Council for confirmation

SECTION 3 All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 4 This ordinance shall be known as Ordinance 20-1

SECTION 5 This ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law
