ORDINANCE AMENDING SECTION 7-7-1 – DEFINITIONS, OF ARTICLE VII –
VEHICULAR FOOD VENDOR OF CHAPTER 7 – BUSINESS CODE OF THE REVISED
CODE OF ORDINANCES OF THE CITY OF SULLIVAN, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Sullivan, Moultrie County, Illinois, that:

SECTION 1: CHAPTER 7 – BUSINESS CODE, ARTICLE VII – VEHICULAR FOOD VENDORS, SECTION 7-7-1 – DEFINITIONS – “Vehicular Food Vendor” is hereby amended in its entirety and shall read as follows:

“Vehicular Food Vendor” means any person engaged in the business of selling food products from a vehicle, self-powered or otherwise, or a trailer or cart in the City limits, provided that the words “vehicular vendor” shall not include salesmen who use vehicles to go from place to place for the purpose of making sales on the premises of a prospective purchaser.

SECTION 2: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 3: This ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law.

SECTION 4: This ordinance shall be known as Ordinance No. 20-11.
