**ORDINANCE NO. 20-12**

**ORDINANCE AMENDING SCHEDULE "D" STREETS HAVING SPECIFIC SPEED LIMITS, TO SECTION 24-4-2 (F) OF THE REVISED CODE OF ORDINANCES OF THE CITY OF SULLIVAN, ILLINOIS**

BE IT ORDAINED BY THE Mayor and City Council of the City of Sullivan, Moultrie County, Illinois, that:

SECTION 1: There shall be an amendment to Schedule "D", Streets Having Specific Speed Limits, adding a 25 MPH speed limit sign on Eastlawn Drive.


SECTION 2: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 3: This ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.


SECTION 4: This ordinance shall be known as Ordinance 20-12.
