ORDINANCE AMENDING SECTION 1-2-3 – MEETINGS OF CHAPTER 1 –
ADMINISTRATION OF THE REVISED CODE OF ORDINANCES OF THE CITY OF
SULLIVAN, MOULTRIE COUNTY, ILLINOIS

WHEREAS, certain sections of the Revised Code of Ordinances of the City of Sullivan need to be amended to reflect the change of the meeting time and location change of the City Council meetings.

NOW, BE IT ORDAINED by the City Council of the City of Sullivan, Moultrie County, Illinois, as follows:

SECTION 1: Section 1-2-3 – Meetings, Division I – Commissioners Duties, Chapter 1 – shall be amended by changing the meeting time to 6:00 p.m. and by changing the meeting location to the Elizabeth Titus Memorial Library, which shall read as follows:

1-2-3 MEETINGS. The regular stated meetings of the City Council shall be held at the Elizabeth Titus Memorial Library on the second (2nd) and fourth (4th) Mondays in each month at 6:00 p.m. during Central Standard Time and Daylight Savings Time. If a regular stated meeting falls upon a legal holiday, the meeting shall be held at the regularly scheduled time and place unless the City Council at the next prior meeting thereto shall determine to reschedule the meeting until the next secular day. Public notice of regular meetings and rescheduled meetings shall be given in accordance with the Open Meetings Act. (see 5 ILCS Sec. 120/1 et seq.)

SECTION 2: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 4: This ordinance shall be known as Ordinance 20-13.


