ORDINANCE NO. 20-17

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES
FOR THE FISCAL YEAR BEGINNING MAY 1, 2020 AND ENDING
APRIL 30, 2021 FOR THE CITY OF SULLIVAN,
COUNTY OF MOULTRIE AND STATE OF ILLINOIS.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SULLIVAN, MOULTRIE COUNTY, ILLINOIS, THAT:

Section 1: That the total amount of appropriations for all corporate purposes legally made to be collected from the Tax Levy and other sources for the current year was heretofore ascertained to be the sum of THIRTY MILLION SIX HUNDRED THIRTEEN THOUSAND SIX HUNDRED DOLLARS AND NO CENTS (\$30,613,600), as evidenced by the Annual Appropriation Ordinance of the City of Sullivan for the year 2020-21 passed by the Mayor and City Council of said City at the legally convened meeting of July 27, 2020.

Section 2: The amount of SEVEN HUNDRED SEVENTY FOUR THOUSAND FOUR HUNDRED TWENTY TWO DOLLARS AND NO CENTS (\$774,422) is hereby levied upon all the taxable property in the City of Sullivan subject to taxation for the current fiscal year. The specific amounts as levied for the various funds heretofore named being included herein by being placed in separate columns under the heading "Amount to Be Raised by Tax Levy", which appears over the same. The tax so levied being the current fiscal year of said City and for the said appropriation to be collected from said tax levy, the total of which has been ascertained as aforesaid, and being as follows:



Section 3: That the Clerk of said City of Sullivan, Illinois on the passage and approval of this Ordinance, shall file a certified copy thereof with the County Clerk of Moultrie County, Illinois, as required by the Statutes of the State of Illinois in such case made and provided.

Section 4: Warrants against and in anticipation of the taxes above levied for the payment of the ordinary and necessary expense of the City of Sullivan for the current fiscal year, are hereby authorized to be drawn by the Mayor, City Clerk and City Treasurer to the extent of seventy-five (75%) per cent of the total amount of any such tax levied herein, in accordance with the Statutes in such case made and provided and subject to the provisions thereof.

Section 5: All ordinances or parts of Ordinances in conflict herewith are hereby expressly repealed. This Ordinance is declared to be urgent and necessary for the immediate preservation of the public peace, health and safety, and shall be in force and effect immediately upon its passage and approval, as provided by law.

Section 6: This Ordinance shall be known as Ordinance No. 20-17




