ORDINANCE NO. 20-4
ORDINANCE AMENDING CHAPTER 33 – STREET REGULATIONS, SECTION 33-2-7
OF THE REVISED CODE OF ORDINANCES OF THE CITY OF SULLIVAN, ILLINOIS

BE IT ORDAINED BY THE Mayor and City Council of the City of Sullivan, Moultrie County, Illinois, that:

SECTION 1: CHAPTER 33 – STREET REGULATIONS, Article II – General Regulations, Section 33-2-7 shall be amended to read as follows:

33-2-7 VEHICLES AND PROPELLED DEVICES ON SIDEWALKS.

No person shall operate, ride or use any vehicle or motive device propelled or designed for propulsion by human power on or over any sidewalk, steps or ramps within the City of Sullivan except when crossing to go into a yard or parking lot. The term "motive device propelled or designed for propulsion by human power" includes: bicycles, tricycles, hoverboards, scooters, skateboards, roller skates, rollerblades or any similar vehicle or toy or article on wheels, but shall not include wheelchairs or other devices operated or used by disabled persons.

SECTION 2: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 3: This ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.

SECTION 4: This ordinance shall be known as Ordinance 20-4.




