ORDINANCE NO. 20-9
ORDINANCE AMENDING CHAPTER 9 CEMETERY SECTION 9-3-5 FEES, OF THE
REVISED CODE OF ORDINANCES OF THE CITY OF SULLIVAN, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Sullivan, Moultrie County, Illinois, that:

SECTION 1: CHAPTER 9 – CEMETERY, ARTICLE III – REGULATIONS, SECTION 9-3-5 shall be amended to read as follows:

9-3-5 FEES. Grave openings shall be Six Hundred Fifty Dollars (\$650) per opening during the week (Monday-Friday), and shall be Seven Hundred Fifty Dollars (\$750) per opening during weekends (Saturday-Sunday) and City holidays. Cremations, entombments and infant grave openings shall be Three Hundred Fifty Dollars (\$350) per opening during the week (Monday-Friday), and shall be Four Hundred Fifty Dollars (\$450) during weekends (Saturday-Sunday) and City holidays.

SECTION 2: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 3: This ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law.

SECTION 4: This ordinance shall be known as Ordinance No. 20-9.


