**ORDINANCE NO. 21-4**  
**ORDINANCE VACATING A PORTION OF ALLEY IN STOCKS AND MONROE**  
**ADDITION BLOCK 1, CITY OF SULLIVAN, ILLINOIS**

BE IT ORDAINED by the Mayor and City Council of the City of Sullivan, Moultrie County, Illinois, that:

It is in the best interests of the City of Sullivan that a portion of alley in Block One (1) of Stocks and Monroe Addition to the City of Sullivan, as described in the attached exhibit A, be vacated; and that the owners of the following parcels of real estate with the following property index numbers adjoining said alley shall be owners of the property thereby vacated: 08-08-02-470-013, 08-08-21-000-216, 08-08-02-455-011, 08-08-02-445-010, and 08-08-02-455-009, a map of said alley to be vacated is attached hereto and incorporated herein.

Provided, that the City retains the right to maintain, operate, repair and replace, by itself or by any licensee or a holder of a franchise from the City, any poles, wires, pipes, conduits, sewer mains, water mains, or any other facility or equipment for the maintenance or operation of any utility now located in the alley or portion thereof vacated by this ordinance.

SECTION 1: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 2: If any part of the ordinance shall be held void, such part shall be deemed severable and the invalidity of this shall not affect the remaining parts of this ordinance.

SECTION 3: This ordinance shall be known as Ordinance No. 21-4.


This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

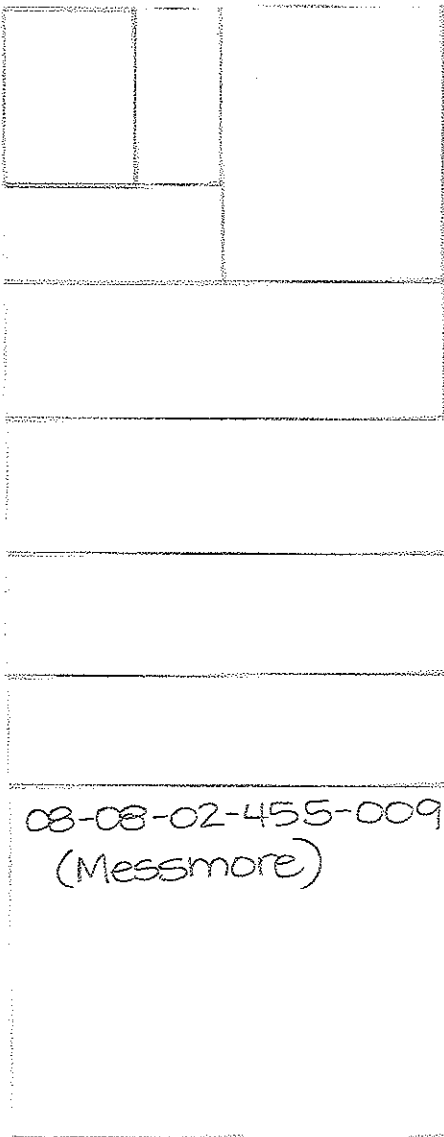
