ORDINANCE 22-2

AN ORDINANCE AUTHORIZING THE CITY CLERK TO UPDATE THE OFFICIAL ZONING MAP AND TO PUBLISH A NOTICE OF THE ZONING MAP UPDATE

WHEREAS, 65 ILCS 5/11-13-19 requires the Corporate Authorities to cause to be published, no later than March 31st of each year, a map clearly showing the existing zoning uses, divisions, restrictions, regulations and classifications of the municipality for the preceding calendar year: and

WHEREAS, said map shall be the Official Zoning Map of the City.

NOW, BE IT ORDAINED by the City Council of the City of Sullivan, Moultrie County, Illinois, as follows:

SECTION 1: That the City Clerk is hereby authorized to have the Official Zoning Map of the City of Sullivan updated to show all existing zoning uses, divisions, restrictions, regulations and classifications in effect as of December 31, 2021; and

SECTION 2: The City Clerk is directed to publish the attached map, in the manner Ordinances of the City are published; and

SECTION 3: That the City Clerk is further directed to publish a Public Notice in the News-Progress announcing that the Official Zoning Map has been updated as required by the Illinois Municipal Code and said Notice shall read as follows:

Notice is hereby given that the Official Zoning Map of the City of Sullivan, as required by 65 ILCS 5/11-13-19, has been updated by the GIS Coordinator and said map has been published, in the manner Ordinances of the City are published. Said Official Zoning Map is available for public inspection in the City of Sullivan Utility Office, 304 S. Hamilton St., Sullivan, IL 61951, or on the City's website at www.sullivanil.us.

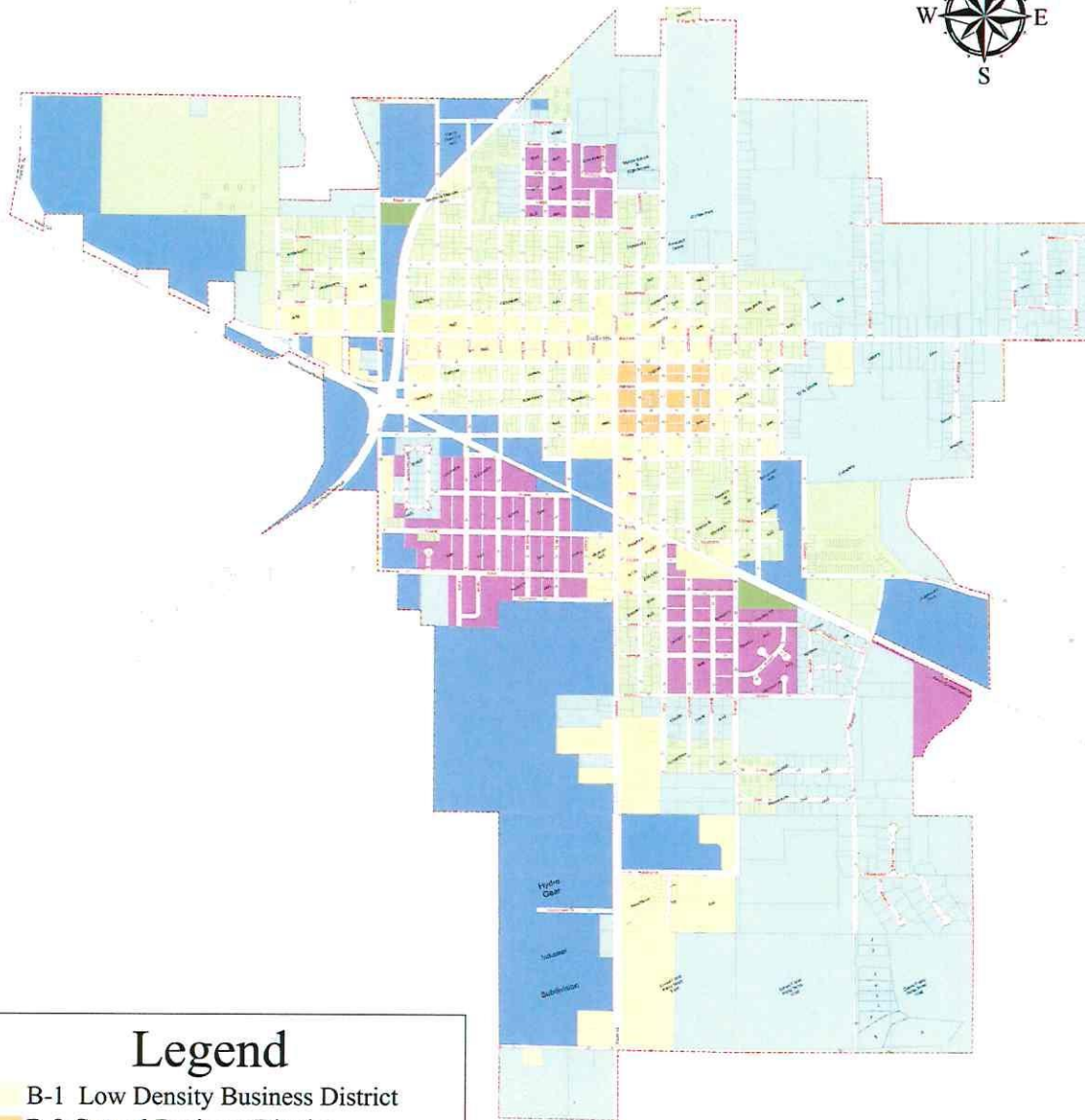

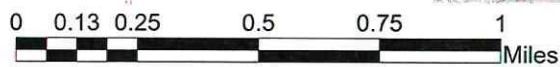
