**ORDINANCE AMENDING CHAPTER 24 – MOTOR VEHICLE CODE,
ARTICLE III – STOP AND THROUGH STREETS,
SECTION 24-3-3 STOP STREETS, SCHEDULE “A” – STOP INTERSECTIONS

BE IT ORDAINED by the Mayor and City Council of the City of Sullivan, Moultrie County, Illinois, that:

SECTION 1: Section 24-3-3 – STOP STREETS, SCHEDULE “A” Section II shall be titled **FOUR-WAY STOPS**.

SECTION 2: Section 24-3-3 – STOP STREETS, SCHEDULE “A” Section II shall be amended by adding thereto:

**SCHEDULE “A”
STOP STREETS**

II. FOUR-WAY STOPS.
E. Mattox and S. Worth

SECTION 3: Section 24-3-3 – STOP STREETS, SCHEDULE “A” Section III shall be titled **THREE-WAY STOPS**.

SECTION 4: Section 24-3-3 – STOP STREETS, SCHEDULE “A” Section III shall be amended by adding thereto:

**SCHEDULE “A”
STOP STREETS**

III. THREE-WAY STOPS.
Kaskaskia Drive and S. Patterson Road

SECTION 5: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 6: This ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.

SECTION 7: This ordinance shall be known as Ordinance 22-4.
