NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SULLIVAN, MOUTRIE COUNTY, ILLINOIS, as follows.

SECTION 1 The Corporate Authorities find that, for the Minutes or portions thereof, as per Exhibit "A" which is attached, it is no longer necessary to protect the public interest or the privacy of an individual by keeping them confidential and such Minutes, which were previously approved in closed session, are to be hereby released.
