

RESOLUTION 19-V

**A RESOLUTION REGARDING THE RELEASE
OF EXECUTIVE SESSION MINUTES**

WHEREAS, the Illinois Open Meetings Act requires all public bodies to keep written minutes of all of their meetings whether open or closed, and,

WHEREAS, the Minutes of closed sessions are only to be available after the public determines that it is no longer necessary to protect that public interest or the privacy of an individual by keeping them confidential, and

WHEREAS, each six (6) months, the public body is to make this determination which can be made in closed sessions, and

WHEREAS, after having reviewed the Minutes of all closed meetings, the Corporate Authorities have determined that, for some of them, the need for confidentiality still exists as to all or part of those Minutes and as for others, as set forth in Section 1 of this Resolution, the Minutes or portions thereof no longer require confidential treatment and should be available for public inspection,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SULLIVAN, MOULTRIE COUNTY, ILLINOIS, as follows

SECTION 1 The Corporate Authorities find that, for the Minutes or portions thereof, as per Exhibit "A" which is attached, it is no longer necessary to protect the public interest or the privacy of an individual by keeping them confidential and such Minutes, which were previously approved in closed session, are to be hereby released.


SECTION 2 This resolution shall be in full force and effect immediately upon its passage.
