**A RESOLUTION REGARDING THE RELEASE
OF EXECUTIVE SESSION MINUTES**

WHEREAS, the Illinois Open Meetings Act requires all public bodies to keep written minutes of all of their meetings whether open or closed; and,

WHEREAS, the Minutes of closed sessions are only to be available after the public determines that it is no longer necessary to protect that public interest or the privacy of an individual by keeping them confidential; and

WHEREAS, each six (6) months, the public body is to make this determination which can be made in closed session; and

WHEREAS, after having reviewed the Minutes of all closed meetings, the Corporate Authorities have determined that the need for confidentiality still exists as to all of those Minutes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SULLIVAN, MOULTRIE COUNTY, ILLINOIS, as follows:

SECTION 1: That the need for confidentiality still exists as to all of the closed session minutes, as per Exhibit "A" which is attached, and shall remain closed to public review until further review and order by the City Council of the City of Sullivan.

SECTION 2: This resolution shall be in full force and effect immediately upon its passage.
