- 7. **Twelve hour shifts for Taneytown Police Department** motion by Vigliotti to approve 12 hour shifts for Taneytown Police Department pursuant to the recommendation of Chief Etzler, which includes time and a half holiday pay, the addition of 1 personal day per year and the idea of 96 hours of roll-over vacation, instead of 80, 2nd by Hale. Mayor Pro Tem Foster expressed that she hopes going forward there will be no need of discussions regarding buy-outs of annual leave. Motion carried 5 0.
- 8. **2020 annual leave pay out** Mayor Wantz stated the buy-out figure is approximately \$14,000.00 for unused annual leave and that he encouraged Chief Etzler and Major Mitchell to use leave and direct officers to do the same, which will reduce the figure. Mayor Wantz recommended a cap of \$14,000.00 on the buy-out amount. Motion by Vigliotti to cap pay-out at \$14,000.00, 2nd by Fuller. After discussion, Vigliotti made a motion to table until the next council meeting with the hope that the figure for pay-out will be lower than \$14,000.00 and withdrew his original motion. Councilmember Fuller withdrew her 2nd to the original motion. Mayor Pro Tem Foster made a 2nd to Vigliotti's motion to table and that motion carried 5 0.
