CITY OF TANEYTOWN NOTICE OF A PROPOSED REAL PROPERTY TAX INCREASE

The City Council of the City of Taneytown proposes to increase real property taxes.

- 1. For the tax year beginning July 1, 2023, the estimated real property assessable base will increase by 3.1%, from \$ 815,415,471 to \$840,660,281.
- 2. If City of Taneytown maintains the current tax rate of \$ 0.3700 per \$100 of assessment, real property tax revenues will increase by 3.1% resulting in \$ 93,406 of new real property tax revenues.
- 3. In order to fully offset the effect of increasing assessments, the real property tax rate should be reduced to \$0.3589 the constant yield tax rate.
- 4. The City of Taneytown is considering not reducing its real property tax rate enough to fully offset increasing assessments. The City of Taneytown proposes to adopt a real property tax rate of \$ 0.3700 per \$100 of assessment. This tax rate is 3.1% higher than the constant yield tax rate and will generate \$ 93,406 in additional property tax revenues.

A public hearing on the proposed real property tax rate increase will be held at 7:30 pm on April 5, 2023, at Taneytown City Hall. This hearing is open to the public, and public testimony is encouraged.
