
Dear Ethics Commission Members;

The checking account "Citizens for Bradley Wantz" is currently in dispute due to fraudulent activity. The "Cash Balance" of \$102.88 on the summary report reflects the proper balance that is supposed to be in the account at this moment.

As of this writing, there have been three fraudulent transactions (currently being disputed) in the amount of \$21.06. The bank has also notified me of additional "pending" transactions that must clear before I am able to dispute them.

When this account is corrected, it will be closed and the remaining funds dispersed pursuant to §18-17(A) of the Taneytown City Code. A final filing will be submitted after these events.


