Upon completion of the interview process, it was the unanimous recommendation of the interview committee that 3 firms were deemed the most qualified to provide engineering services to the Village of Tinley Park. The recommended firms are (presented in alphabetical order):

- Baxter & Woodman
- Christopher B. Burke Engineering
- Robinson Engineering

The 3 firms were recommended based on several factors, including, but not limited to, the following:

- Reference Checks
- Government Experience
- Quality & Experience of Staff
- Oral Interview Quality
