**Item #1** - The meeting of the Public Safety Committee Meeting was called to order at 6:47 p.m.

**Item #2 – CONSIDER APPROVAL OF THE MINUTES OF THE PUBLIC SAFETY COMMITTEE MEETING HELD ON JUNE 13, 2017** – Motion was made by Trustee Brady, seconded by Trustee Younker to approve the minutes of the Public Safety Community Meeting held on June 13, 2017. Vote by voice call. Chairman Brady declared the motion carried.

**Item #3 – DISCUSS NEIGHBORHOOD WATCH PROGRAM** – During past Village Board meetings, more than one resident requested the police department participate in the Neighborhood Watch. The citizens requesting the program were not specific in the details of the type of program they would like to see. In an effort to identify the community need, Trustee Brady and Village Manager Dave Niemeyer met with two community representatives on August 9, 2016.

Police Chief Steve Neubauer provided an overview of the traditional Neighborhood Watch program and the current Crime Prevention Program the Village provides.

The Tinley Park Police Department supported a traditional Neighborhood Watch program in the 1990s. By 2005, interest in the program waned. The program was modified to holding centralized meetings that featured a speaker and crime prevention material. The crime prevention officer was assigned different duties.

## **Minutes**

### **Meeting of the Community Development Committee**

**July 11, 2017**

The goal of the Neighborhood Watch is to prevent crime. Currently, the Tinley Park Police Department participates in several crime prevention programs. There are two civilian crime prevention specialists and also several officers who assist with various programs. Additionally, the police department puts out timely press releases and works with the marketing department to get other information to the public on an as-needed basis. The police department has made improvements since talks convened last year and would be willing to have additional conversations on additional ways to improve the program.

#### **ITEM #4 – RECEIVE COMMENTS FROM THE PUBLIC –**

Wilma Penny - Started her own Neighborhood Watch Program for her block. Suggested that a specific location be designated for residents to pick up information about what's going in the community.

Resident 2 – This resident was on the original Neighborhood Watch Program in the 1990s. Suggested using a national program to be used by the police department to obtain training materials free of charge. The materials help to communicate valuable training information to dog walkers and others who may be home during the day. It teaches what to look for and things that should raise concern. Resident states she had given her contact information to Trustee Glotz in case Chief Neubauer would like to contact her.

Trustee Brady announced to invite the citizens to National Night Out on August 1, 2017 at Zabrocki Plaza.

The Public Safety Committee will be discussing this item at the August 8, 2017 meeting.

This ordinance amendment will change the method of fund receivership from the current practice. At present, the funds paid to the Tinley Park Foreign Fire Insurance Board (FFIB) are received by the Village Treasurer and are deposited into an interest bearing account maintained by the Village. A separate line item is established in the budget that shows account balance and activity. When the FFIB approves a purchase, funds are drawn from the account for the purchase in accordance with Village purchasing practices. Periodic reports are furnished to the FFIB by the Village on fund balance.

The Illinois Statute (Public Act 96-505 amended ILCS 5/11-10-2) requires that funds be received by the FFIB Fund and they establish the accounts and maintain the fund. A meeting between the Village Manager, Treasurer and Village Attorney took place to discuss this change in process and it was determined that this action would align this function with the intent of the Illinois Statute. The FFIB will receive the funds directly from the Village and will provide periodic reports to the Village and conduct an annual audit of funds paid for by the FFIB.

Additionally the title President when referring to the FFIB Board position is changed to Chairman to be consistent with the Statute and other references within the ordinance.

**WHEREAS**, Section 6(a) of Article VII of the 1970 Constitution of the State of Illinois provides that any municipality which has a population of more than 25,000 is a home rule unit, and the Village of Tinley Park, Cook and Will Counties, Illinois, with a population in excess of 25,000 is, therefore, a home rule unit and, pursuant to the provisions of said Section 6(a) of Article VII, may exercise any power and perform any function pertaining to its government and affairs, including, but not limited to, the power to tax and to incur debt; and

**WHEREAS**, the Corporate Authorities previously adopted Section 32.230 Chapter 32 Title III of the Tinley Park Municipal Code establishing a Foreign Fire Insurance Board; and

**WHEREAS**, the Corporate Authorities previously adopted Section 32.231 Chapter 32 Title III of the Tinley Park Municipal Code establishing powers, duties, and procedures for the Foreign Fire Insurance Board; and

**WHEREAS**, the Corporate Authorities hereby desire to amend Section 32.232 of Chapter 32 Title III of the Tinley Park Municipal Code establishing fund accounting, investment, and invoice rules for the Foreign Fire Insurance Board; and

**WHEREAS**, the Corporate Authorities hereby desire to amend Section 32.232 of Chapter 32 Title III of the Tinley Park Municipal Code to appropriately identify the authority of the Treasurer and replace the office title of President with the title of Chairperson; and

**WHEREAS**, the Corporate Authorities of the Village of Tinley Park, Cook and Will Counties, Illinois, have determined that it is in the best interests of said Village of Tinley Park to

amend Section 32.232 of Chapter 32 Title III of the Tinley Park Municipal Code pursuant to this Ordinance; and

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Tinley Park, Cook and Will Counties, Illinois, as follows:

**Section 1:** The Preambles hereto are hereby made a part of, and operative provisions of, this Ordinance as fully as if completely repeated at length herein.

**Section 2:** That Title III Chapter 32 Section Subsection A (32.232(A)) of the Tinley Park Municipal Code entitled “Fund Accounting/Investments/Invoices” is hereby amended by deleting the language in its entirety and replacing it with the underlined text as follows: following strikethrough language and adding the following underlined text:

**§ 32.232 FUND ACCOUNTING/INVESTMENTS/ INVOICES.**

(A) The Treasurer of the Foreign Fire Insurance Board shall receive the appropriated money, deposit the monies into a separate, interest bearing account established by the Foreign Fire Insurance Board, and shall pay out the money upon the order of the Foreign Fire Insurance Board for the maintenance, use and benefit of the department as provided in the Illinois Municipal Code 65 ILCS 5/11-10-2. The account shall be maintained, monitored and audited consistent with the procedures and controls for the village's other accounts. All interest shall be credited to the Foreign Fire Insurance Fund. The Treasurer shall provide periodic reports to the Foreign Fire Insurance Board Secretary regarding the status of the budget accounts of the Fund.

**Section 3:** That Title III Chapter 32 Section 231 Subsection D (32.232(D)) of the Tinley Park Municipal Code entitled “FUND ACCOUNTING/INVESTMENTS/INVOICES” IS hereby amended by deleing the strikethrough language and replacing it with the underlined text as follows:

**§ 32.232 FUND ACCOUNTING/INVESTMENTS/ INVOICES.**

(D) The President Chairperson and Treasurer of the Foreign Fire Insurance Board shall approve all invoices to be paid following the same policies and controls used for payment of other Foreign Fire Insurance Board invoices. No payment shall be made, however, without an order from the Board and authorization in the annual budget approved in accordance with § 32.231.

**Section 4:** Any policy, resolution, or ordinance of the Village of Tinley Park that conflicts with the provisions of this Ordinance shall be and is hereby repealed to the extent of such conflict.

**Section 5:** That this Ordinance shall be in full force and effect from and after its adoption and approval.

**Section 6:** The Village Clerk be and hereby is authorized and directed to publish this Ordinance in pamphlet form.

Dave;

The Fire Department is submitting this proposal as part of the FY18 budget for new apparatus. The budget contains a line item for this purchase in the amount of \$1,500,000 and is designated for a Tower Ladder. This request includes a request for this vehicle and an engine and will demonstrate that through contributions from the TPFD Association and by using prepayment options and the sale of existing units that both vehicles can be purchased within the budgeted amount.

1. Purchase a new 100' Tower Ladder to replace Tower 47 (0023) for a price of **\$1,355,195.00**.
  - a. The TPFD Firefighters Association will contribute 20% towards the purchase of this unit in an amount not to exceed \$260,901.60
  - b. The existing reserve Tower Ladder 47 (2000 E-One 95') will be placed up for sale through an apparatus broker with an asking price of \$125,000.
    - i. Current front line Tower Ladder 48 (2005 E-One 95') will be placed into reserve status with a replacement date scheduled for FY2030.
  - c. A pre-payment option offered by Pierce Manufacturing will reduce the new vehicle purchase by \$54,753.
  - d. If VOTP requires performance bond, then we will need to add \$4,066 to the original price.





**Subject:** Police Department Staffing Analysis

In the 2018/2019 budget, funds have been allocated for a staffing study for the police department. A police staffing study is a complex undertaking to determine if the police department is staffed appropriately to effectively respond to calls for service now and in the future. The study will include, but is not limited to, the following.

- Determine the number of field patrol officers and supervisors currently required to enable a department to:
  - Respond to emergency demands of citizens in a timely manner;
  - Respond to non-emergency demands of citizens in a timely manner;
  - Conduct prevention and other proactive patrol tasks effectively, including community-oriented policing and problem solving;
  - Conduct all other necessary patrol tasks effectively, including traffic control and special missions;
  - Allow officers to meet all administrative requirements satisfactorily, including report writing, training, court, and personal needs; and
  - Promote the safety of the public and police officers.
- Assess gross patrol staffing requirements for the immediate future.
- Suggest a plan for deploying the required number of patrol officers and supervisors most cost effectively by shift and patrol area in response to geographical incidence of crime and demands for non-crime services.
- Identify crimes, victims, and police services that require more effective response.
- Evaluate how productively personnel and other resources are used to conduct current operations.
- Project future workload and service demands.
- Specify appropriate levels of personnel needed to conduct current and future departmental operations.
- Identify functions performed by a department that can be performed more effectively by alternative means and/or agencies.

A request for proposal has been prepared for the purpose of establishing a contract with a qualified firm to provide consulting services for a Police Department Staffing Analysis. I would request the Public Safety Committee's approval to seek qualified candidates to conduct a staffing analysis per the Request for Proposals.

## Performance of System

## Overview of Security Policy

Our policy has been designed to ensure that the platform shall be secured to the greatest extent commercially possible to protect against the consequences of breaches of confidentiality, failures of integrity or interruptions to the availability of that information. This policy provides management direction and support for information security across the entire organization. Specifically, information security policies of our third-party service providers shall be considered part of this information policy and shall have equal standing. Further, this policy has been ratified by the organization and forms part of our Policies and Procedures. It has been communicated to all staff and other relevant parties. This policy shall be reviewed and updated regularly to ensure that it remains appropriate in the light of any relevant changes to the law, organizational policies and contractual obligations.

To determine the appropriate level of security measures applied to each information system, a process of risk assessment is carried out for each system to identify the probability and impact of security failures. To manage information security within the organization, a senior officer is charged with the responsibility of overseeing this process and updating the rest of management. The objective of this process is to ensure that there is clear direction and visible management support for security initiatives and shall promote security through appropriate commitment and adequate resourcing.

Amazon Web Services has been selected by management due to their commitment to security around customer data. Their Policies, Procedures and Certificates will be reviewed at least quarterly to ensure that they remain “best in class.” Appropriate alternatives will be developed as needed if it is determined that they no longer hold this classification.

# Security of Data

The In-telligent platform has three components:



All of a Community's related information will be hosted at AWS and can only be accessed through the mobile and web-based Applications. This connection is encrypted to ensure that it can only be viewed through the Administrative Portal and the Mobile Applications.

AWS maintains best in class security over their systems. White papers prepared by AWS on their systems can be accessed through the following links:

All information and access to the system is hosted in the Cloud. No data is resident on a Community's servers, nor is access to a Community's proprietary networks required or desired for the In-telligent platform to work. This ensures that no one can hack into a Community's data through the In-telligent platform, nor can unauthorized users of the In-telligent system gain "backdoor" access through the Community's network.

## Limitation on Liability

Risk exist whenever messaging is transmitted from one source to another. At In-telligent, we make the allocation of responsibility and therefore, liability, simple:

In-telligent is responsible for ensuring that messages sent through the portal will reach all the targeted users designated by a Community's Administrators

In-telligent is responsible for ensuring that a Community's designated Administrators are sending messages that satisfy our General Terms and Conditions

A Community is responsible for the content of the messages that are sent through the platform

A Community is responsible for determining the frequency of messages and the severity of the In-telligent notification that accompanies each message


