## Food and Beverage Vendor Information

After a community poll, “80’s Life Amplified” has been selected as the theme for the 20<sup>th</sup> annual Downtown Tinley Block Party. As one of Tinley Park’s favorite events, we expect approximately 20,000 people to attend throughout the day.

The ‘80s ushered in lots of foods and drinks that are still incredibly popular today: Cool Ranch Doritos, bread bowls and Sloppy Joe’s. It was also a great decade for food commercials; who can forget the dancing California Raisins, Michael Jackson hawking Pepsi or the Wendy’s “Where’s the beef?” lady? Please help to play up the theme and be creative with menu items and signage.

**Vendor Selection Process:** First preference is given to Downtown Tinley businesses, then to those who participated in the 2017 Block Party. Following, all Tinley Park restaurants/food providers will take preference. Please do not remit payment until the Block Party Organizers have confirmed your participation. If approved, this Vendor Agreement entitles your business to set up in one outdoor location which will be assigned. **To be considered, applications must be turned in by May 15.** Vendor options include:

- Outside Food Vendor (No tents or tables provided) \$850**
- Outside Liquor Vendor (No tents or tables provided) \$1,500**
- Outside Snack Vendor (No tents or tables provided) \$425 (ex: popcorn, ice cream)**

**All applicants must hold a current restaurant/food provider Tinley Park Business license and employ a State of Illinois Certified Food Manager. Liquor vendors must have a valid Tinley Park Liquor License in good standing.**

Once approved, a deposit of 50% will be due by June 4, 2018 in order to ensure your participation at the Block Party. Final payment will be due no later than June 25. **No refunds will be issued if the block party is cancelled due to inclement weather or for any other reason.**

\*A \$100 discount is offered for Food Vendors only without a storefront within the Block Party limits.
