Community Manager Report

- Margaret met with Justin Hill of Desert Vista Concrete regarding fountain repairs, with different options for edging and lighting being considered.
- DLC will remove old irrigation lines behind to 40316 N Candlewyck Lane to prevent further leakage and erosion, AG & CC will repair their portion.
- 2023 Election ballots have gone to print, there are 3 candidates for 2 ACCCA positions and two candidates for 1 ACC position.

New Business

- Margaret shared that Precision Concrete is working with AG & CC to mediate trip hazards.
- AG & CC has a Trespass Order now in effect with MCSO.
- Margaret continues to work with Monty Becton, sharing contacts and ideas on improving safety and communication.
- ABDi Gate Access has a Fast Access electronic guest pass program to provide easier and more accurate access for Club resident's vendors and guests. It will facilitate efficient check-ins and eliminate address entry errors.
 - Skip motioned to approve the purchase and implementation of the program. Initial investment will be approximately \$3,000.00 paid from #51276 equipment G/L. Ongoing investment will be \$125.00 monthly from #51164. 2nd by Janie and agreed unanimously upon by the Board.
