# Administrative Session - Board of Directors Meeting October 6, 2022 – 3:00pm Meeting Minutes

## Call to Order/Verification of Quorum

Dave Duckworth called the meeting to order @ 3:01pm and quorum was verified.

# Approval of Minutes – September 1, 2022

• Skip Hoeder made a motion to approve minutes, 2<sup>nd</sup> by Greg Strand. Motion was approved unanimously.

# **Community Manager Report**

- Margaret shared the Volunteer Appreciation event information.
- iCan Access and Video started October 1<sup>st</sup> as the new gate maintenance company.
- Sunstates Security took over gate operations on Monday, October 3<sup>rd</sup>.

# **Board Liaison Reports**

- **GPP** The Committee is working on emergency communication protocols and has contacted DMFD and MCSO for a future meeting.
- Dave will discuss recruitment with newly appointed Chair, Rick Kesselman.
- **Finance** Greg reported on recent investments: \$675K went into a 2 year Treasury @ 4.14% and \$500k was split into two equal CD's @ 4.35%.
- Policy With no appeals scheduled for September, the meeting was canceled.
- LEC No committee update was given due to Janie Murnane's absence.

#### **New Business**

• The LEC put forth a recommendation to approve a new committee member, Liane Burton. Steve Champion motioned to approve her appointment, Skip Hoeder 2<sup>nd</sup>. Unanimously approved.

- The GPP committee lost Don Trefry as chair due to Don moving out of Anthem, with Rick Kesselman being chosen as the proposed replacement. Greg Strand motioned to approve and appoint Rick as the Chair, Skip Hoeder 2<sup>nd</sup>. The Board voted unanimously to approve.
- New flag statutes were introduced, adding First Responder Flags. The thin blue line and thin red line flags were not included in the new State statute, which went into effect September 24, 2022.
  Steve Champion proposed a motion that the ACCCA policy only allow the flags permitted by Arizona State Law. Skip Hoeder 2<sup>nd</sup> the motion and the Board agreed unanimously.

## **Old Business**

- 2023 Budget talks resumed, with a recommendation by the Finance Committee for a proposed increase of 5.25%. The current and future Reserve funding, and increasing expenses were discussed. A 5% draft scenario (subject to change) will be shared with homeowners via the community website. Further adjustments and clarifications will be made for presentation and final vote at the quarterly Board meeting held on October 27<sup>th</sup>.
- Margaret shared the status of the Verizon negotiations with Communications Consulting Group, noting there is a slight delay due to Verizon staffing, and hoping to have numbers in the next few days. A special Board meeting (with 48 hours' notice) will be called when the numbers come in.
- The additional expense for concrete cutting by Precision Concrete was unanimously approved on a motion by Steve Champion with a 2<sup>nd</sup> by Greg Strand.
