

DOG PARK RULES

The Dog Park is for the enjoyment of Anthem residents & authorized guests.

- Park is for Anthem residents only with required dog park registration. For registration information, visit [OnlineAtAnthem.com](https://www.onlineatanthem.com).
- Use of the dog park is at your own risk. Owners or custodians of a dog are legally liable for the acts and conduct of the dog at all times within the dog park.
- The following items may not be used or otherwise brought into the park: prong, electric and spike collars; muzzles, food, treats, alcohol, or glass; bicycles or strollers; smoking/vaping or tobacco products of any kind; or personal agility equipment.
- Children under the age of 14 must be accompanied by an adult.
- No more than two (2) dogs are permitted per responsible dog handler.
- Dogs must be collared at all times while within the park, and must display the Maricopa County license tags and the collar tag issued by the Anthem Community Council.
- Dogs must be leashed when entering and exiting the park. Maricopa County leash laws must be observed at all times outside of the designated off-leash zones.
- Dogs must be unleashed within the designated off-leash zones.
- Dog handlers must be present, in sight, and maintain voice command of the dog at all times.
- Dog waste must be cleaned up immediately and disposed of in the receptacles provided.
- Dogs, owners, and park users creating a disturbance or violating rules must immediately leave the park if/when requested by law enforcement and/or park personnel.
- For the safety of all dogs, immediately leash your dog if it exhibits aggressive or anti-social behavior and leave the off-leash area.
- Dogs may not be groomed within the park. Professional dog trainers and/or groomers are not permitted to conduct business.
- Dogs in heat and puppies under six (6) months are not permitted.
- The park is private property reserved for members. No trespassing. The Anthem Community Council will not be responsible for any injury caused while trespassing.
- Entry constitutes your voluntary consent to assume all risks and dangers, including injury to persons or dogs that may occur.
- Entry constitutes your release and discharge of the Anthem Community Council from all claims, actions, liabilities, and damage arising from injuries to persons or dogs, including claims resulting from any actual or claimed negligent acts or omissions, active or passive, by the Anthem Community Council, its directors, employees, volunteers, or agents.
