The Belton City Council met in an in-person/virtual meeting via Zoom due to the COVID-19 Public Health Emergency that has been declared by Governor Greg Abbott, Bell County Judge David Blackburn and Belton Mayor Marion Grayson. Staff present included Sam Listi, John Messer, Amy Casey, Gene Ellis, Bob van Til, Jon Fontenot, Cheryl Maxwell, Paul Romer, Chris Brown, Matt Bates, Mike Rodgers, Susan Allamon and Jeremy Allamon.

The Pledge of Allegiance to the U.S. Flag was led by Mayor Pro Tem Wayne Carpenter, and the Pledge of Allegiance to the Texas Flag was led by Interim Director of Public Works Jeremy Allamon. The Invocation was given by Councilmember Craig Pearson.

  - Maintain a competitive staff compensation plan









# WHAT IS A CAPITAL IMPROVEMENTS PLAN (CIP)?

- A Capital Improvements Plan represents the City's plan for infrastructure development over a specified time period here, five years
- Plan is reviewed annually to reflect changing priorities and to provide a framework for identifying capital requirements
- The CIP consists of three sections:
  - Project name and cost estimates
  - Possible sources of funding
  - Effect upon future operations and maintenance costs





## WHY CREATE A CIP?

- Capital planning ensures that essential government services can be provided in the future
- It helps ensure the continued financial health of the City and represents a government "Best Practice"
- It implements capital components of the Strategic Plan





## HOW IS A CIP DEVELOPED?

- Management assembles projects anticipated for the next five years
- Costs are estimated and possible funding sources are recognized
- Changes to operations and maintenance costs are projected
