6. Minutes of the previous meeting.

7. Consider a resolution authorizing the City of Belton to opt in to the Texas Department of Housing and Community Affairs (TDHCA) HOME Single Family Program Reservation System, for Homeowner Rehabilitation Assistance (HRA), and authorizing the City Manager to act as the City's authorized representative in all matters pertaining to the City's participation in the program.
8. Consider an ordinance prescribing the classifications for police officer and firefighter positions and the number of positions in each classification, correcting the number of positions in the Fire Department.
9. Consider authorizing a Leadership Belton project for the placement of a City of Belton welcome sign and landscaping to be located at the northeast corner of the intersection of West Avenue D and Loop 121.

10. Hold a public hearing and consider an ordinance regarding a zoning change from Agricultural to a Single Family-2 Zoning District for 30.71 acres, Highland Estates, Phase II, located northeast of the Sparta Road and Wheat Road intersection and north and west of the existing Highland Estates Subdivision, Phase I.
11. Consider approval of a resolution authorizing the City Manager to enter into a Chapter 380 Agreement with Prestwick Development; and consider approval of a related budget amendment from the Water & Sewer Fund.
12. Consider authorizing a Development Agreement with Best Construction for infrastructure improvements at the Piazza Development, an 11.23 acre tract located at the southwest corner of Auction Barn Road, Shanklin Road, and Loop 121, and approving related budget amendment from the Drainage Fund.
13. Consider authorizing the City Manager to take all steps necessary to acquire 207 Smith Street, the north half of Lot 3, Block 3, W.Y. McFarland Addition, and pursue its redevelopment.
