CANDIDATE ELIGIBILITY REQUIREMENTS	DEADLINE TO FILE CANDIDATE APPLICATION**	
<ol style="list-style-type: none"> <li>1. Must be a United States citizen.</li> <li>2. Must be a registered voter on the date of the election.</li> <li>3. Must be a resident of the City of Belton for one (1) year prior to the date of the election.</li> <li>4. Must be a minimum of 18 years of age.</li> <li>5. Must not be delinquent on any indebtedness to the City.</li> <li>6. May not be an employee of the City of Belton.</li> <li>7. May not hold any other elected public office.</li> <li>8. Candidates may only file for one office per election.</li> <li>9. Must not have been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated; or partially mentally incapacitated without the right to vote.</li> <li>10. Have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities.</li> <li>11. Candidate Packets, including the application, are available in the City Clerk's Office.*</li> </ol>	<p>February 16, 2024 by 5:00 PM for May 4, 2024 General Election</p> <p>February 14, 2025 by 5:00 PM for May 3, 2025 General Election</p>
