Ordinance #9–20-09-OA: BOND ORDINANCE PROVIDING FOR IMPROVEMENTS TO THE MANITOU PARK SCHOOL HOUSE, BY AND IN THE TOWNSHIP OF BERKELEY, IN THE COUNTY OF OCEAN, STATE OF NEW JERSEY; APPROPRIATING \$1,750,000 THEREFOR (INCLUDING A GRANT FROM THE NEW JERSEY HISTORIC TRUST IN THE AMOUNT OF \$656,537) AND AUTHORIZING THE ISSUANCE OF \$1,041,393 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF
