

ORDINANCE NO. 2022-36-OA<sup>B</sup>

**AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE DONATION OF AN EASEMENT ON A PORTION OF BLOCK 169.01, LOTS 1 & 2, TO THE BERKELEY TOWNSHIP SEWERAGE AUTHORITY, IN ACCORDANCE WITH N.J.S.A. 40A:12-1 ET SEQ.**

**August 22, 2022**

**WHEREAS**, the Township of Berkeley is the owner in fee simple of certain real property located in the Township of Berkeley, County of Ocean, New Jersey, designated as Block 169.01, Lots 1 & 2 on the official Tax Map of the Township of Berkeley; and

**WHEREAS**, the Berkeley Township Sewerage Authority has requested a Sanitary Sewer and Access Easement for a 20' and 30' wide sanitary sewer located in Block 169.01, Lot 1, which easement totals 1.07 acres, as more fully described in Schedule A attached hereto and made a part hereof; and

**WHEREAS**, the Berkeley Township Sewerage Authority has requested a Sanitary Sewer and Access Easement for a 30' wide sanitary sewer located in Block 169.01, Lot 2, which easement totals .07 acres, as more fully described in Schedule A attached hereto and made a part hereof; and

**WHEREAS**, the Township of Berkeley has agreed to grant this Sanitary Sewer and Access Easement to the Berkeley Township Sewerage Authority for the construction, operation and maintenance of its appurtenances; and

**WHEREAS**, N.J.S.A. 40A:12-5 authorizes a municipality to donate property by the adoption of an ordinance authorizing same.

**NOW, THEREFORE, BE IT ORDAINED** by the governing body of the Township of Berkeley, County of Ocean, State of New Jersey as follows:

**SECTION 1.** That the governing body does hereby authorize a Sanitary Sewer and Access Easement for a 20' and 30' wide sanitary sewer located in Block 169.01, Lot 1, and a Sanitary Sewer and Access Easement for a 30' wide sanitary sewer located in Block 169.01, Lot 2, as more fully described in Schedule A attached hereto and made a part


hereof. This property is being donated by the Township of Berkeley pursuant to N.J.S.A. 40A:12-5 to The Berkeley Township Sewerage Authority.

**SECTION 2.** That the Mayor and Municipal Clerk are hereby authorized to execute any and all documents necessary for the donation of the subject property to The Berkeley Township Sewerage Authority.


**SECTION 3.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 5.** This ordinance shall take effect after second reading and publication as required by law.
