

ORDINANCE NO. 2023-10-OAB

**AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE TOWNSHIP CODE, SO AS TO AMEND CHAPTER VII, ENTITLED "TRAFFIC" §7-13.1, ENTITLED "PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS" (VEEDER LANE)**

*February 27, 2023*

**BE IT ORDAINED** by the Mayor and Township Council of the Township of Berkeley, County of Ocean, and State of New Jersey, as follows:

**SECTION 1.** Chapter VII of the Township Code of the Township of Berkeley, entitled "Traffic," is hereby amended so as to amend §7-13.1, entitled "Parking Prohibited at All Times on Certain Streets," to include the roadway listed below which shall read as follows:

**§7-13.1 PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS.**

No person shall park a vehicle at any time upon any streets or parts thereof described, except where other parking regulations have been provided for.


<u>Name of Street</u>	<u>Sides</u>	<u>Location</u>
Veeder Lane	South	Between 75 feet west of Deal Avenue and Moorage Avenue

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 4.** This ordinance shall take effect after second reading and publication as required by law.
