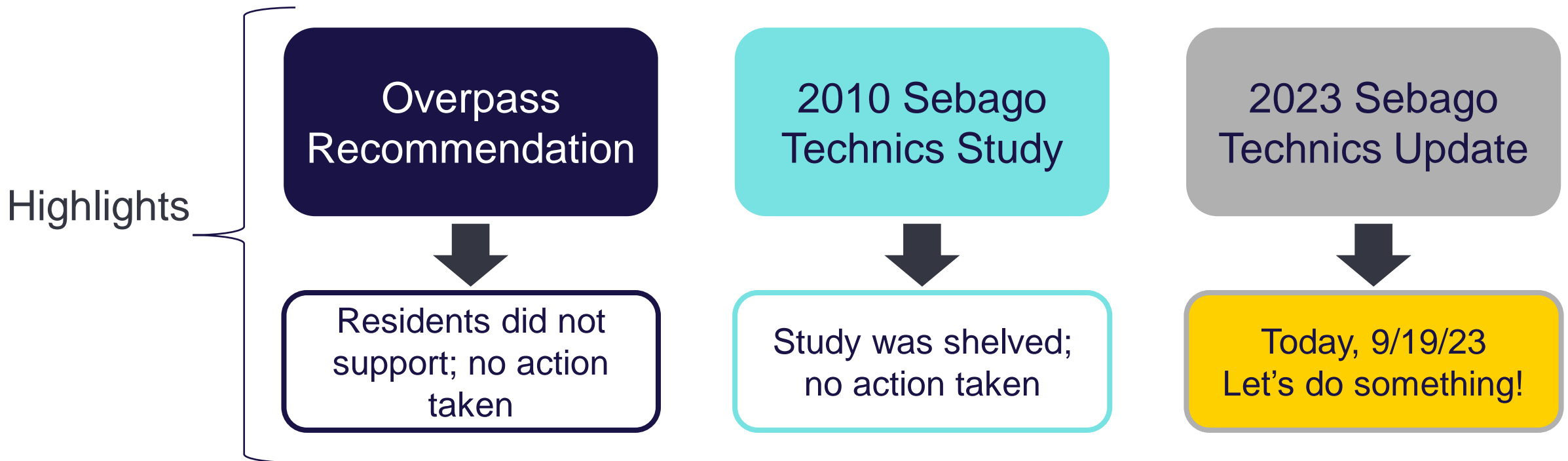

- No change/do nothing

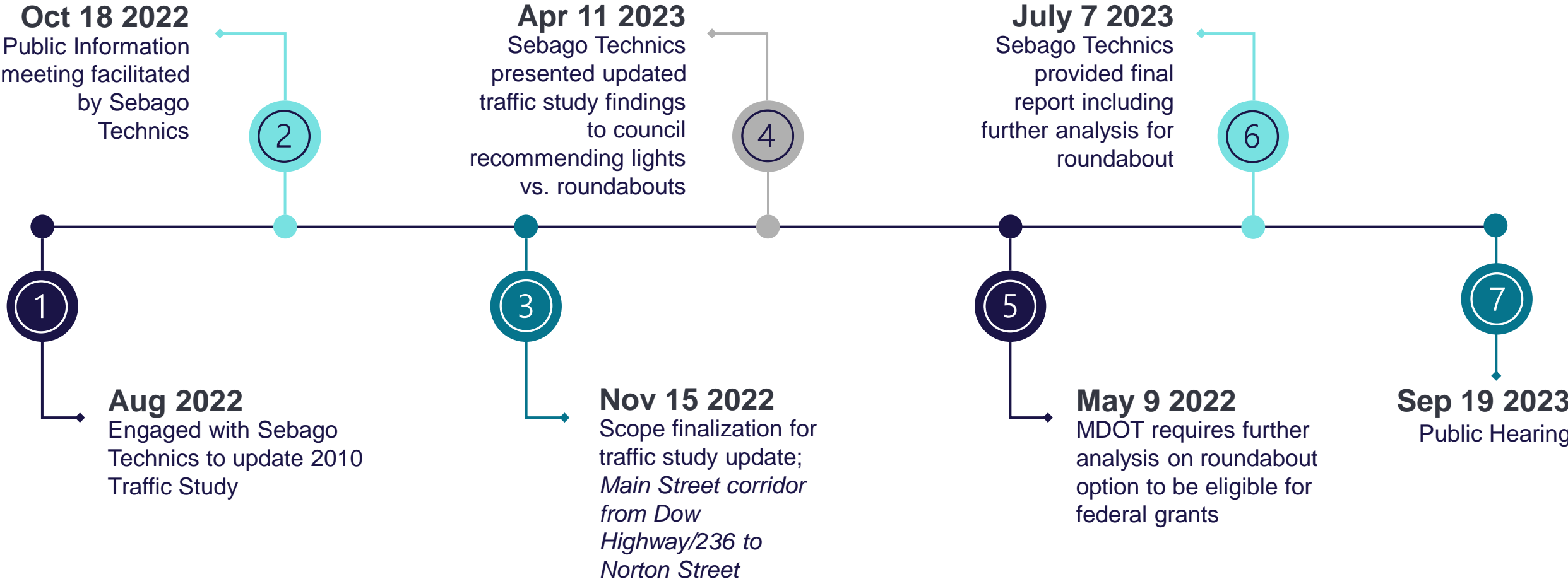


History

- 17 traffic studies completed in South Berwick since 1985



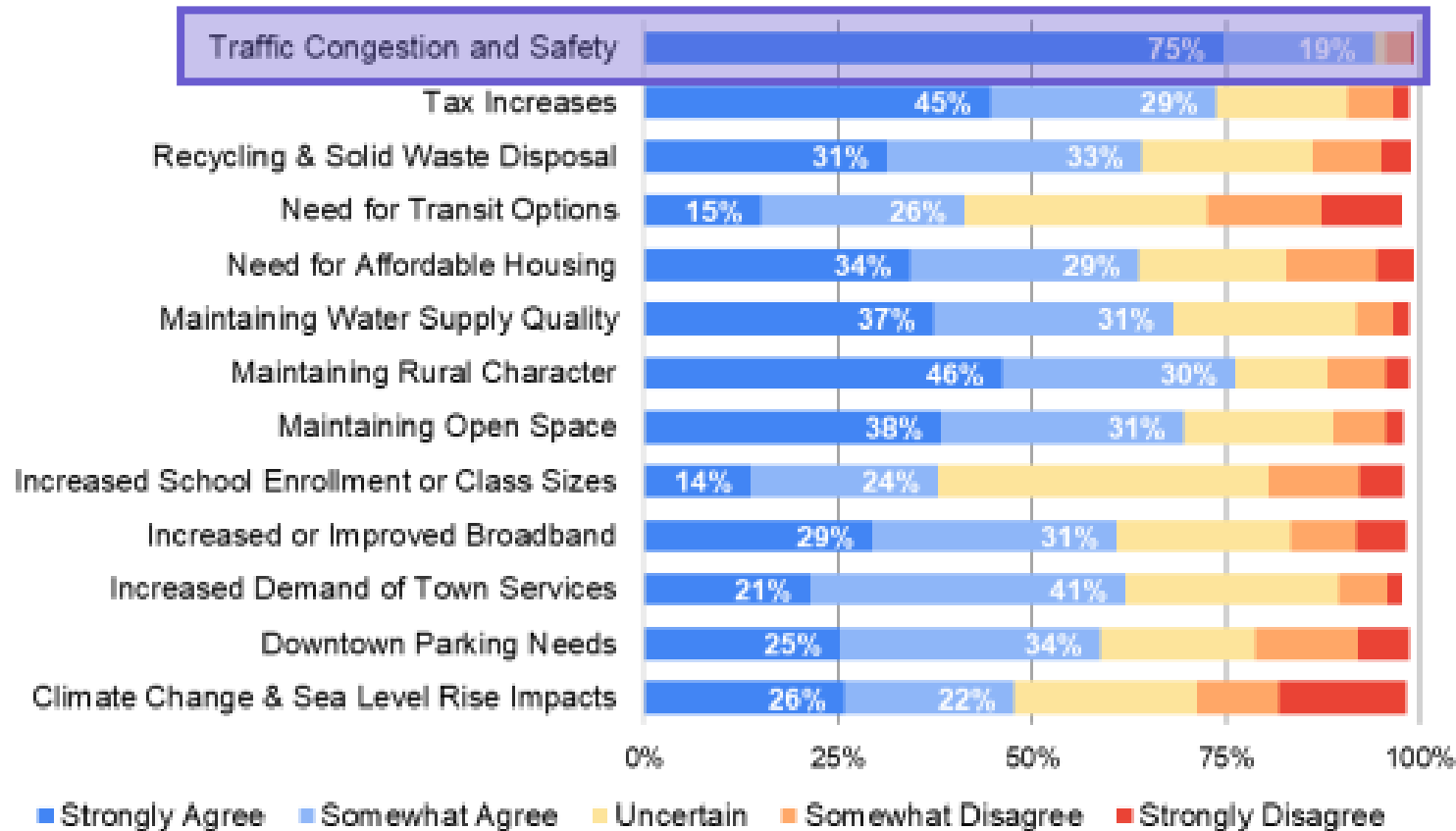
Recent Milestones



Traffic congestion & safety has been a challenge for decades

Results from 2022 Community Opinion Survey for Comprehensive Plan

“_____ is a serious challenge facing South Berwick in the next 5 years.”



- In 2022:
 - 75% strongly agree
 - 19% somewhat agree
- In 2003:
 - 80% strongly agree
 - 15% somewhat agree

Sentiment has remained the same for almost 20 years!

- Almost all respondents agree that Traffic Congestion and Safety is an issue, regardless of age.



Key Takeaways from 2023 Sebago Technics Study

Sebago Technics confirmed what we already knew

- ✓ Speeding is problematic at times
- ✓ Traffic calming is a high priority
- ✓ Significant amounts of traffic make intersection movements challenging
- ✓ Corridor lacks pedestrian visibility
- ✓ Pedestrians do not feel safe

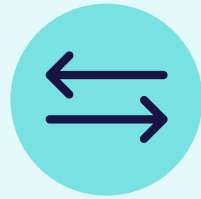


Recommendations from 2023 Sebago Technics Study

Traffic lights at both intersections will provide **greatest flexibility**



Ability to retime signals as traffic patterns grow & change



Ability to coordinate the two signals to optimize traffic through the corridor



Greater retainage of parking in vicinity of downtown business

Roundabouts **not recommended**

- Portland & Main
Not enough space for future growth of traffic volumes

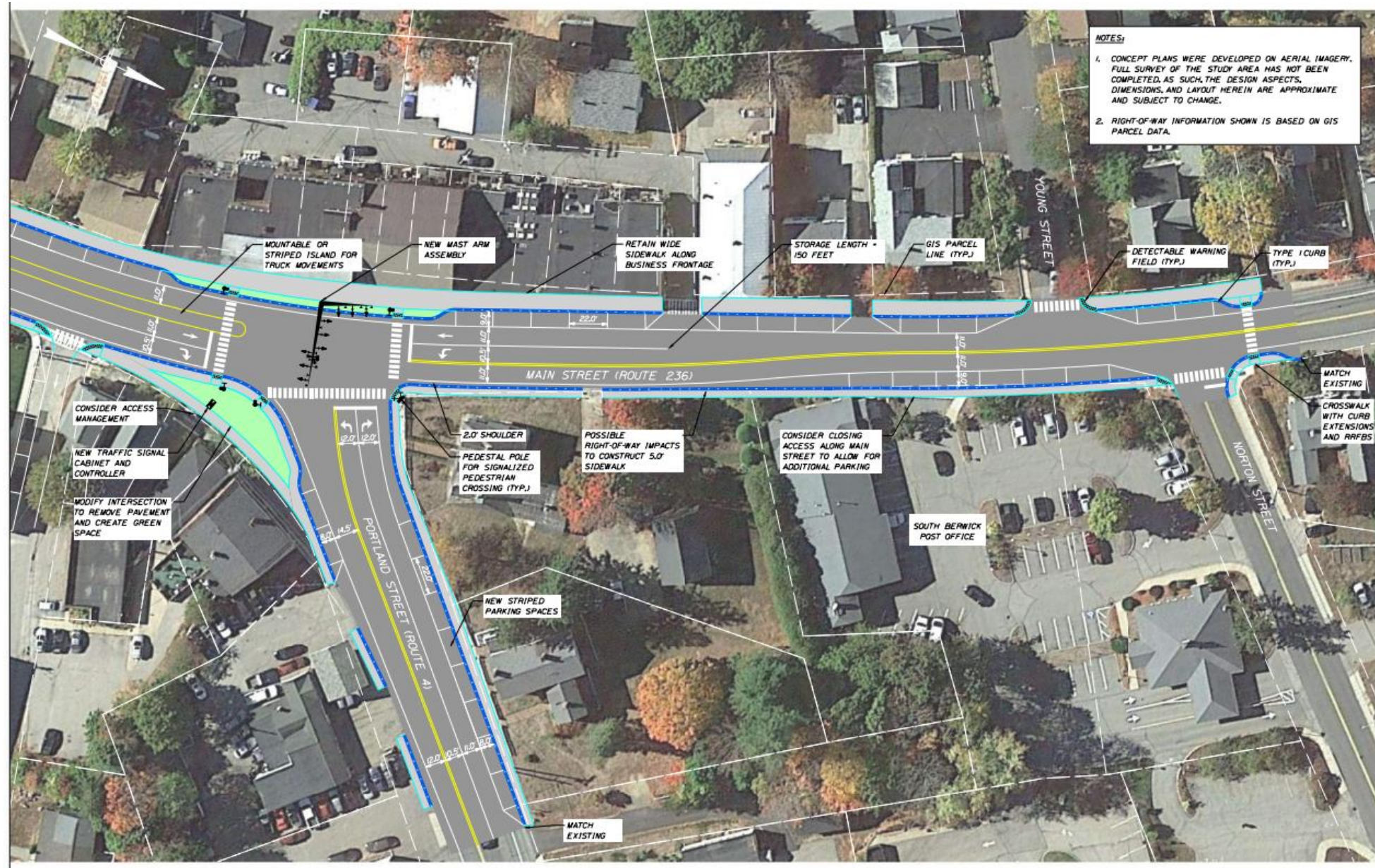

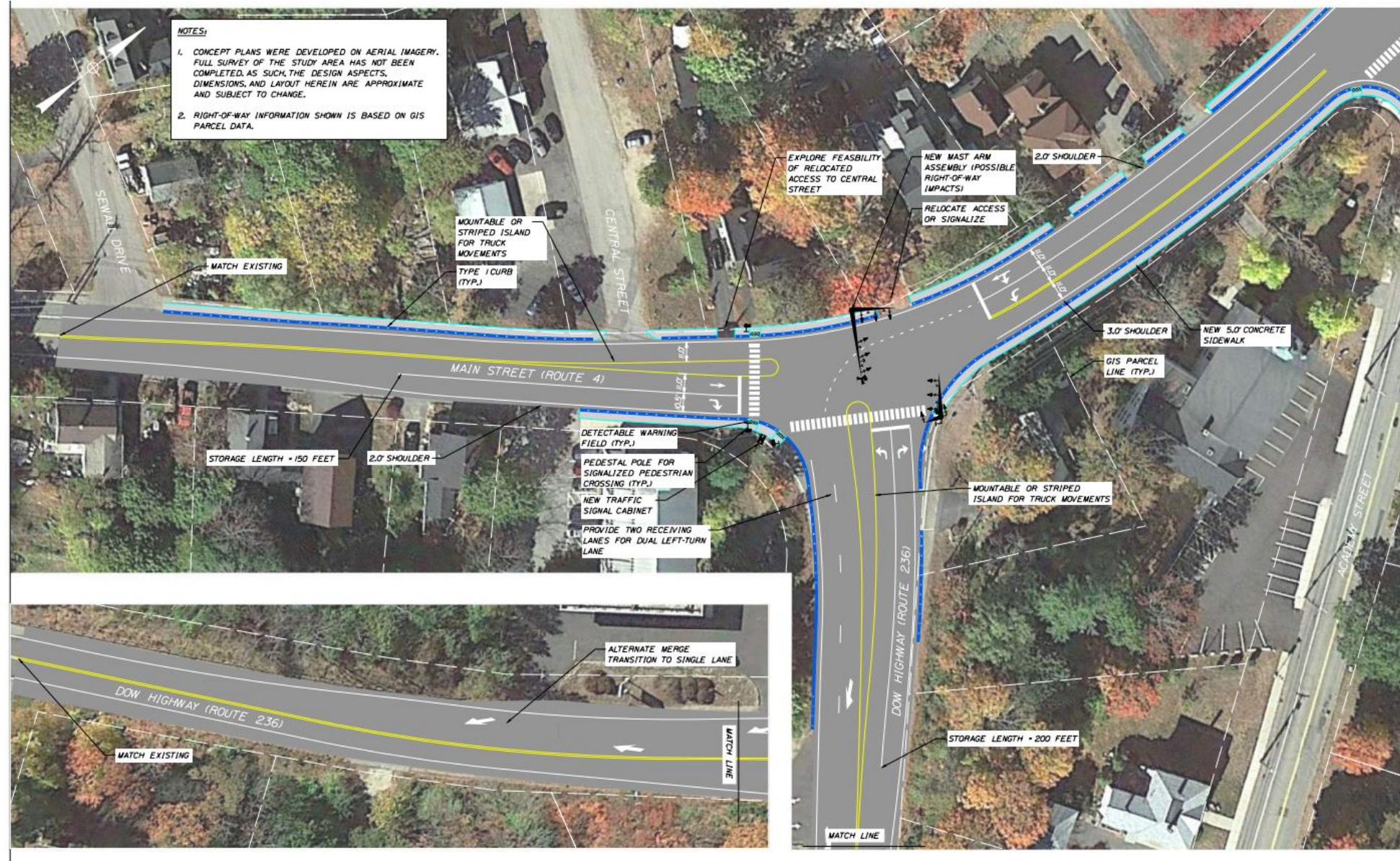

Long term improvements with traffic lights

- Reduction in diverted traffic through **local neighborhoods**
- **Pedestrian phase** that operates with **stopped vehicles** as opposed to yield
- **Retain wide sidewalks with greenspace**, creating room for planters, benches, banners, etc.



- **Improved response time** for emergency vehicles through corridor
- Coordination between signals to **optimize traffic flow**
- **Increased visibility for pedestrians** at unsignalized crosswalks using rectangular rapid flashing beacons

Partnership with Maine Department of Transportation (MDOT)

If project is approved by Town Council, the state will fully support the project

- MDOT will allow South Berwick to skip the conceptual design phase because the Sebago Technics report has met the conceptual design requirements
 - Saves South Berwick money and time
- MDOT will advance funding toward preliminary design & construction of South Berwick traffic project
 - Move budget from FY26 to FY24, expediting process
 - Estimated cost for preliminary design is ~\$500K and requires a 20% match by the town
 - South Berwick contribution would be \$100K (funded from TIF, not from tax dollars)
- MDOT will be the project manager, oversee RFP for construction services, and overall process



Next Steps & Go Forward Process

- On 9/26/23, Town Council will vote on whether or not to move forward with traffic project after 9/19/23 public hearing

If an affirmative vote from council:

- Kick off design efforts with MDOT
- Public hearing(s) as design develops
- Add page to town website for traffic project
