I strongly encourage the town to consider acquiring a second opinion on the cost to renovate vs build new.

The previous study seemed extremely skewed and the costs involved seemed inflated in favor of a new build.

In addition, a town hall that is only open to residents 3 days per week does not warrant the construction of an extremely large building.

The current town hall has ample space for the services provided and the employees it houses.

The first floor could easily be renovated to support the offices that are currently located on the second floor, all while keeping the (somewhat) day to day functions operational.

OR consider an addition on to the community safety building and relocate the town hall there.

Furthermore, the number of services that can be processed remotely are growing every year. Why plan to expand an office that will likely be phased out over time?

I believe tax payer money should not be utilized to fund the construction of a new building when there are more economical options.

I am unable to attend tonight's hearing on the sale of existing town hall and the proposed new town hall to be built in open space in the Shoetown area. **I would like to go on record as being opposed to the sale of town hall and/or the construction of a new town hall for the following reasons:**

- The existing town hall is in the perfect location for a town hall- in the center of town;
- Town hall is likely the best constructed building in town hall. It was built by the Catholic Church, who did not construct shabby buildings;
- The building seems to be deemed old and antiquated by some and in need of repairs. Since the town acquired the building in the 1970s, little regular maintenance has been completed on the building. If regular maintenance were budgeted for the building and completed, it wouldn't need a lot of work;
- There have been complaints about the interior workability of the building. No one has indicated that there has been any effort to address the workability of spaces and ergonomics of the spaces and work areas;
- With all the deferred maintenance, a work plan for improvements could be generated and improvements could be made slowly and within budget without having to bring the building fully up to code. New windows and an insulated roof would be the top priorities in my book, with making the spaces more functional and comfortable for employees;
- With the police department moving out to a new space, the existing town hall has been deemed "too big" by some insiders. The building can be reprogrammed to accommodate maker's space, incubator space, etc. The lower floor is ideal for office and other uses for new fledgling businesses;
- The town really couldn't afford the new police station so, in retrospect, there should have been an addition to the existing town hall for new police station features, verse a totally new police station;
- Any proposed location for a new town hall would compromise the integrity of an existing neighborhood and would increase traffic, diminish open space, and compromise the quality of life for those residents living in the neighborhood;
- Having viewed the financials for old and new town halls, I don't believe the numbers and believe a new building would not be as good as the refurbished existing town hall in the best location for the use;
- Given the lack of maintenance on any of the town's buildings, why would a new town hall be built, only to have it fall into disrepair, as there will be no maintenance budgets;

I have much more to say but, suffice to say, the existing town hall is a fine building, could be reprogrammed for more uses and should be our town hall for years to come. While the public may not be apprised of all the facts and details, I have heard that the former town manager wanted to sell the building and already had "deals in the works." I am hoping that this hearsay is inaccurate and would hope that the Town Council would look at all the facts in an open and transparent manner.

Having worked in municipal government for several decades, I am familiar with circumstances such as the town hall issue and continue to believe that the existing town hall is in the right location and that the deferred maintenance can be corrected over time.

Future generations will deplore the choice to sacrifice our dignified Town Hall and the absolutely vital green space around it, if you make the mistake of selling this irreplaceable asset. It's value as the centerpiece of town layout and the symbol of our small town meeting democracy can't be reproduced. Giving up that space will only diminish the appeal of South Berwick to visitors and residents. In 2016 an attempt was made to build the police station at the proposed location for the new town hall. The town chose to preserve the rare downtown green space as well as the playground. It took 2 years, countless meetings and workshops, who knows how much money spent on appraisals and plans for the town to finally break ground at a different location. We don't need to do that again. All the reasons for not building on the playground and in the field still exist. Congested residential area, bad intersections, narrow streets, increased traffic, increased light and noise pollution, loss of green space, loss of playground, and the Fire department objection.

Our town hall is centrally located, quintessential New England look, has more room than we know what to do with, and a great centerpiece for our community. The problem is that it hasn't been maintained properly. I don't know why that happened but it makes me very reluctant to want to build a new town hall for millions. If we haven't maintained the one we've had since 1975 it's a pretty hard sell that the new town hall will be adequately cared for given the 48 years our current one hadn't been.

Lastly, there has been a little confusion as to what kind of structure is being proposed. The initial concept in June 2022 was a small footprint directly on the current playground. (See first attachment) A new playground was to be built next to that. I assume where the tennis court is now. But the most recent mock up available to the public appears to take up all of the playground and the tennis court and a portion of the green space with no new playground at all. (See second and third attachments) Given that these are both very different concepts a little clarification as to what is being suggested would be helpful. Either way the location isn't what the town wants, just like in 2016.

Obviously my household will be voting against the new town hall in favor of the old. Please, let's not waste any more money and any more time trying to develop land that the town has already decided it does not want developed. Save the current town hall.

To the South Berwick Town Council;

I am writing on behalf of the South Berwick Historic District Commission to provide comments on the topic of the future of the town hall building. The question that has been presented to the council and its citizens can be distilled down to two options: preservation versus replacement. Although the initially presented options to the building committee show that a new town hall would be cheaper than preservation, there are many aspects that are not included in these figures. It is difficult to put an exact price on preservation, there are many benefits. Historic preservation has been proven over the years to be advantageous to the local economy, it makes use of an existing building that is perfectly situated in town for the function it provides, and it serves as an anchor in a well established downtown area. With regard to town hall, quite simply, the building is already there. Agreed, it needs work but all of the issues that have been presented are not impossible to fix. In many cases, the issues are a result of deferred maintenance rather than poor initial construction or design flaws. In addition to already having a building that is currently functioning as a town hall, the extra space could be used for other tenants. The building has ample parking and associated green spaces surrounding it, utilities are in place and it is in close proximity to the downtown business area. These are examples of items that are difficult to put a price tag on, but they are definitely an asset to the existing building.

Preservation projects have well documented in the past that they provide a greater economic impact than new construction. More jobs are created through preservation projects and in many cases those jobs are more likely to use local craftspeople than large scale new construction. South Berwick has a large population of skilled preservation professionals who have dedicated their careers to these type of projects. One valuable resource for planning a preservation project is a book titled "The Economics of Historic Preservation; A community leaders guide" by Donovan Rypkema. I can provide a copy to the town council.

Finally, we need to only walk through the down town area to see successful preservation and adaptive reuse projects that are performing exceptionally well. We have restaurants in historic buildings, law offices, doctors offices, boutique shops and salons, real estate offices and a library that have all made use of existing structures to provide a place for gathering that are qualitatively more comfortable to be in than a newly constructed building.

Please feel free to reach out to the committee if you have any questions. We look forward to working with you as this project moves forward.

However, it is my understanding that it would cost considerably more to renovate the existing town hall than to build a new town hall and the renovated town may still have some restrictions due to the structure of the existing building.

A few of things that I did not hear during the public comments, are:

1. That the sale of the existing town hall could be put towards the building of the new town hall, further decreasing the cost of building new.
2. If, the cost of renovating the existing town hall is indeed much more expensive than building new, renovating is going to put additional tax burden on citizens when the tax burdens are already high enough.
3. I worked at the Shipyard for 34 years. The Shipyard has many old buildings and I worked in one for many years that had been renovated from a different use just prior to me moving into it. Although a lot of money was spent renovating and qualified architects were hired to designed the building, the renovated building had some serious problems. First a mold problem developed with the new HVAC system that was so bad it effected one worker's health so much that he had to leave the Shipyard and to this day suffers serious health effects. Second, the HVAC system that was installed was undersized, poorly designed and the equipment was outdated, so after many attempts to fix and long periods of inadequate heating and cooling, the unit had to be replaced at some cost. Third, the fire suppression system was run in the attic of the building during the renovation. When insulation was added to try and deal with the inadequate heating system, the fire suppression system had to be re-run in the office space (at additional cost) because the attic became too cold (pipes would freeze). Not all renovations go bad, but some due.
4. Would it be possible to place some sort of restrictions on the sale of the existing town hall so that it's facade and grounds would remain the same and keep feeling that the existing building provides.
5. One thing that I have never understood is why the town's school's facilities are not utilized more. After all, the citizens of South Berwick pay for the schools. To me, the gym at Central School provides a perfect venue for large town gatherings that usually do not take place during school hours and it has great packing and easy access (no stairs to the third floor).

So, with the current understanding that it is much cheaper to build new than to renovate, I would vote to build a new town hall.
