AN ORDINANCE ANNEXING TO THE CITY OF BEULAH, NORTH DAKOTA, THE FOLLOWING DESCRIBED REAL PROPERTY, TO-WIT:

Lot One (1), Block One (1), Nies Addition to City of Beulah, Mercer County, North Dakota.

Said Addition tract contains 0.88 acres, and is subject to all easements of record or apparent on the ground.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEULAH, MERCER COUNTY, NORTH DAKOTA:

WHEREAS, a Petition signed by more than three-fourths (3/4) of the qualified electors and by the owners of more than three-fourths (3/4) of assessed value of the property hereinbefore described, which said property is contiguous to the incorporated limits of the City of Beulah, and not embraced therein, has been presented to the City Council for consideration; and

WHEREAS, in accordance with Section 40-51.2-05 of the North Dakota Century Code, as amended, a Notice of Hearing said Petition was duly published in the Beulah Beacon, Beulah, North Dakota, the official newspaper of the City of Beulah, Mercer County, North Dakota, on the 8th day of May, 2014, which said Notice notified the owners of any and all lots, tracts, or parcels of land above described, that said Petition would be heard on the 19th day of May, 2014, at 7:00 o'clock P.M. (CT) in the City Hall in the City of Beulah, Mercer County, North Dakota.

That pursuant to said Notice of Hearing Petition, a hearing was had and no one appeared in protest to said Petition.

THEREFORE, it is hereby ordained by the City Council of the City of Beulah, Mercer County, North Dakota, as follows, to-wit:

That the following described tracts, lots, parcels, or parts described as follows, to-wit:

Lot One (1), Block One (1), Nies Addition to the City of Beulah, Mercer County, North Dakota, said parcel containing 0.88 acres, and subject to all easements of record or apparent on the ground.

be and the same is hereby annexed to the City of Beulah, and that it is a part of said City of Beulah, Mercer County, North Dakota, and that this Ordinance becomes effective immediately upon its final passage and recording with the County Recorder's Office for Mercer County.

FURTHER, said Petition requested that the District Zoning Map for the City of Beulah be amended to reflect a change in the zoning designation for the above described Lot One (1), Block One (1) Nies Addition to the City of Beulah, Mercer County, North Dakota from its current zoning designation of County Commercial to that of Commercial District (C-1). That no one appeared in protest of this request and, THEREFORE, it is further ordained by the City Council of the City of Beulah, Mercer County, North Dakota, that the current zoning designation of County Commercial be amended to reflect Commercial District (C-1) for and upon Lot One, Block One (1) Nies Addition of the City of Beulah, Mercer County, North Dakota, and this zoning amendment becomes effective immediately upon the final passage and recording of this Ordinance with the County Recorder's Office for Mercer County.
