MINUTES

Schulz moved to dispense with the reading of the minutes of the last regular meeting on March 18 and approve as furnished to the Council by email. Miller seconded. Roll call vote found Miller, Daede, Timmer and Schulz in favor.

PUBLIC INPUT

School House Apartments: Shari Hafner commented on \$1,306.90 in expenses incurred after the water main breaks due to sediment in the pipes. The City Attorney stated the claim will need to be filed with the city's insurance, NDIRF, and an adjuster will assess the situation. Any claims should be turned in to NDIRF. The city has a list of contractors that are bonded if water lines need to be repaired.

Water Service Line: Judy Jose has been out of water for more than a month and has been carrying water. She has chiropractor and plumbing expenses. The City Attorney recommended filing a claim. The city water department flushed the fire hydrant on Friday to make sure water services were working properly. The resident is responsible for the pipes from the house to the corporation on the main.

Garrison Area Improvement: Miller moved to approve the Site Authorization at Fanatics for July 1, 2019 to June 30, 2020. Daede seconded. Roll call vote found Miller, Daede, Timmer and Schulz in favor.

A moment of silence was taken for the passing of former council member Albert Aanderud.

COUNCIL PORTFOLIOS

Mayor Frey - March Madness Conference update on topics covered. The Prairie Dog bill has passed in the legislature and the requirement will be for cities to use the funds for infrastructure such as water, sewer and streets.

Council Member Schulz – Schulz moved to accept the municipal court report as presented. Timmer seconded. Roll call vote found Miller, Daede, Timmer and Schulz in favor. Ashely Nordstrom was hired as the Pool Manager. West River Transit will have their annual public meeting in two weeks. The Transfer Station will move to summer hours starting Monday, April 8.

Council Member Timmer - Heritage Park requests \$6,903 for electricity. Timmer moved to dispense the \$6,903 as an electricity reimbursement to JDA. Schulz seconded. Roll call vote found Miller, Daede, Timmer and Schulz in favor.

Council Member Daede - There was a pre-construction meeting this afternoon on the Lime Removal project for the South Lagoon. It will start soon after the ice is off the lagoon. The intake pipe will also be repaired.

CITY PERSONNEL

City Coordinator - The Knife River got to a high level but didn't move past the flood plain area. There was some damage to banks along the river. Data has been gathered regarding the bridge gage. P&Z reviewed marijuana ordinances and it is recommended to have Solem Law put together a comparison review on it. Miller moved to approve a review through Solem Law for the medical marijuana ordinances. Daede seconded. Roll call vote found Miller, Daede, Timmer and Schulz in favor.

Granville Brinkman was introduced as Economic Development Director.

City Attorney - Resolutions creating and defining the boundaries for the districts and resolutions directing the city engineer to prepare the plans and specs were presented. Timmer moved to approve Resolution 2019-2, 12th Street project, creating and defining the boundaries for the districts. Daede seconded. Roll call vote found Miller, Daede, Timmer and Schulz in favor. Schulz moved to approve Resolution 2019-2, 12th Street project, directing the city engineer to prepare plans and specs. Daede Seconded. Roll call vote found Miller, Daede, Timmer and Schulz in favor. Timmer moved to approve Resolution 2019-3, Gateway Addition project, defining the boundaries for the districts. Daede seconded. Discussion followed on the boundaries. Interstate Engineering will look at a culvert that may be undersized in the ditch, which would be a separate problem. Roll call vote found Miller, Daede, Timmer and Schulz in favor. Schulz moved to approve Resolution 2019-3, Gateway Addition project, directing the city engineer to prepare plans and specs. Daede Seconded. Roll call vote found Miller, Daede, Timmer and Schulz in favor.

Police Chief - Adam Baker will be starting as Police Officer on April 15.

Public Works - The Water Department cleaned out Lift #1 and Lift #8.

City Engineer - An easement negotiation is taking place with MDU for the Gateway Addition project. Lift Station #2 pumps are being reviewed for purchase. The 2018 Sanitary Sewer Lining Project should start in May. Street Repair Projects bids are due April 5.

Schulz moved to pay the bills as presented. Timmer seconded. Roll call vote found Miller, Daede, Timmer and Schulz in favor.
