## CITY COUNCIL MEETING

The regular meeting of the Beulah City Council was called to order at 7:00 pm by Mayor Travis Frey with Council Members Kelsey Timmer, Gary Miller, David Ripplinger, Kathy Kelsch, Loren Daede, Clyde Schulz and David Czywczynski present. Eric Hoffer absent.

Kelsch moved to dispense with the reading of the minutes of the last regular meeting on January 20 and approve as furnished to the Council by email. Miller seconded. Roll call vote found Ripplinger, Czywczynski, Schulz, Timmer, Daede, Kelsch and Miller in favor.

# All Class Reunion Committee update report and financial request:

The Reunion will be July 31 - August 2 and activities were reviewed. Bands are scheduled for Friday and Saturday. A registration letter is currently being prepared. The city has \$5,000 in the budget. Schulz moved to approve the \$5,000 allocation to the alumni for the All-Class Reunion. Kelsch seconded. Roll call vote found Ripplinger, Czywczynski, Schulz, Timmer, Daede, Kelsch and Miller in favor.

## Council Member Timmer

A group toured the Bismarck and Mandan libraries.

## Council Member Kelsch

City Lot Committee has met and it was decided that it would be best to contact the existing residents in Barton Estates since they signed a covenant. The Committee will have more information soon.

#### Council Member Daede

In the process of looking for a dump truck, a vac truck was found in St. Cloud. It would be a benefit for cleaning out deep lift stations and would also serve as a sewer jet. The company in St. Cloud will get back to Yeager with more information. It's listed at \$49,500. Daede moved to approve Yeager and Mattheis to travel to Minnesota to review the vac truck and make an offer on it if it would be a good purchase. Schulz seconded. It was discussed that it will be reviewed as to whether the sewer

jet the city currently has would be kept or sold. Roll call vote found Ripplinger, Czywczynski, Schulz, Timmer, Daede, Kelsch and Miller in favor.

Used pickups are also being looked at for Public Works to replace one that was damaged. Dump truck specifications were delivered to some businesses. Sewer line televising was discussed.

# Council Member Ripplinger

Trees for the Sun Valley RV Park have been ordered.

# Council Member Schulz

Schulz moved to accept the Municipal Court Report. Ripplinger seconded. Roll call vote found Ripplinger, Czywczynski, Schulz, Timmer, Daede, Kelsch and Miller in favor. Pool Board will be meeting shortly to review repairs and hiring of pool employees.

## Mayor Frey

There is a proposal to manage the Sun Valley RV Park with the option to purchase in the future. The current expenses of the RV Park were discussed. It was stated that if the RV Park is leased, it would be taxed. The Comfort Station could also be set up as a lease to purchase. The Census report on city limits is being worked on now.

## CITY PERSONNEL

# **Economic Development Director**

A response was received from the USDA lease and they would like information back. The Bismarck and Mandan libraries were visited to find out about programs. Local lenders may have the ability to provide for local projects just as the Bank of ND can do.

ND Main Street Initiative Proclamation from North Dakota Commerce allows the city to apply for grants by adopting the proclamation. Timmer moved to approve adopting the ND Main Street Proclamation. Kelsch seconded. Roll call vote found Ripplinger, Czywczynski, Schulz, Timmer, Daede, Kelsch and Miller in favor.

Rural Transportation Project information was distributed to Council. It will be pursued if there is a project planned.

Two meetings were held regarding the possibility of a downtown project. Preliminary loan approval was received from BND. The meetings with downtown business owners were held to find out if the project is something they would be interested in. Only one block was looked at because of cost. It is based off a book created by the city in 2013. Of the feedback received from property owners from 1<sup>st</sup> to Central, all but two are in favor of a voluntary assessment. One owner would like to wait until after this year and one is against the project. This is only to see if there is interest; it was never committed and there were no promises made. It will be up to Council to decide if they would like to move further on the project. There is a lot of support of a project downtown. Reducing the slope on the sidewalks is one item as the sidewalks downtown are not promoting a safe environment.

Frey stated debt limit of the city is based on a percentage of the taxable value of the city; some debt would qualify towards the debt limit and some would not. A water or sewer project funded by utility rates using a revenue bond would not qualify towards the debt limit. There would be a review of the city's financials during a loan application process for a project. Utility rates were discussed.

# City Engineer

Storm Sewer Improvement Districts #2 and #3 pay estimates were presented but they will be discussed further with Wagner Construction.

2020 Street Maintenance Repairs – a list was sent out regarding areas that need to be addressed. The intersection at Central Ave and  $7^{th}$  Street needs to be repaired frequently and other alternatives are being looked at.

Pipe Detectives are able to televise sewer lines. They will stand by the numbers presented this year, but will increase next year. Televising 7<sup>th</sup> Street and south would be the area to start.

# **City Coordinator**

The drawings for the safe room were distributed. The cost of the unit will be \$63,500. The total project cost is \$98,595. The city's cost will be 25% of the total cost. It has been discussed to have a mural painted on the outside. The trees are to be planted in Sun Valley RV Park and the school will have students help plant them. The High School had a planning meeting for demolition and construction and they would like to have the plan complete in March.

# Police Chief

The sidearm replacement program has started. They purchased Glock G45 9mm guns. The current firearms were sold through the company to the officers.

# Public Works Superintendent

Lift #2 went down; a float needed to be changed.

## City Auditor

Kelsch moved to approve the Site Authorization for Beulah CVB at Alibis Lounge for a poker tournament on March 7-8, 2020. Miller seconded. Roll call vote found Ripplinger, Czywczynski, Schulz, Timmer, Daede, Kelsch and Miller in favor.

Schulz moved to pay the bills as presented and reviewed. Daede seconded. Roll call vote found Ripplinger, Czywczynski, Schulz, Timmer, Daede, Kelsch and Miller in favor.
