**RESOLUTION ADJUSTING RATES FOR THE COLLECTION OF GARBAGE
AS PROVIDED BY THE CITY OF BEULAH, NORTH DAKOTA**

WHEREAS, the City of Beulah has an established enterprise for garbage collection provided to the residents and businesses in the City of Beulah.

WHEREAS, the City Council of the City of Beulah has reviewed the revenues and expenditures of the garbage collection enterprise and determined a rate increase is necessary to balance the aforementioned revenues and expenditures.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Beulah, North Dakota that the following monthly rates become effective on the 1st day of January, 2024. This Resolution shall be published in the City of Beulah's official newspaper, pursuant to Ordinance #403, Article 10-313, Article 10-314 and Article 10-317.
