1) USDA Building

4) Strategic Plan

1) Government Grants

Beaver noted the number of grants that are available to businesses and other entities. Many businesses miss out as they have no email address. The feasibility of hiring a grant writer was discussed along with the possibility of sharing the cost with other communities such as Hazen.

2) Old Ace Hardware Store

A formal request will be presented at JDA's October meeting.

3) Insurance

JDA has now been added as an additional insured to B'Dolce's Bakery policy.

4) Bakery Loan Term & Refinance

The refinance for the B'Dolce's Bakery property will be coming due.

Addendum A Strategic Plan

1. Interest Buy Downs with the Bank of North Dakota Priority Level: High

A local bank partners with the BND. It is generally referenced as a Pace Buy down. It reduces the interest to be paid back by the borrower and provides the ability to build up equity quicker. Kim noted that additional guidelines are needed.

2. Rent Buy Downs/Rental Assistance

Priority Level: High

Rental assistance is paid to the business for a set period of time. Beaver noted that this option provides flexibility.

3. Revolving Loan Fund

Priority Level: High

This would be a new option for JDA. It would be able to provide loans at lower interest rates and to businesses that might not be able to secure a loan from a financial institution. Current forms of assistance can be rolled into

this option which includes:

Store Front/Signage (Low)

Remodel

Expansion (High)

Purchase (High)

- 4. Store Front Grants Moved to RLF
- 5. Signage Grants Moved to RLF
- 6. Beautification Loans/Grants

Priority Level: Medium/Low

This would tie in with initiatives undertaken by the City.

- 7. Seller Financing/Contract for Deed-Equipment/Real Estate Priority Level Low This would be similar to the funding provided to the bakery.
- 8. Highly Valued/Educated Employee-Assistance

Priority Level: High

Student Loan Forgiveness

This would assist businesses with staffing and hiring based upon the expertise that might be needed.

9. Angel Fund Priority Level: Medium

Individuals in the community would provide the funding for different businesses.

10. Million Doller Cup Priority Level: Low

11. Educating Board Priority Level: High

12. Employee Number

13. Grant Writing Priority Level: High

Hiring a grant writer might be considered. Reaching out to other communities to share the position will be reviewed.

Other Considerations

- There will be a need to market the programs once they have been decided. Clyde will work with the Chamber in advertising the options.
- The focus is facilitating educating marketing.
- The League of Cities is a good resource in developing these programs.
- Commitment is needed along with being present and participation.
