The regular meeting of the Beulah City Council was called to order at 7:00 pm by Mayor Travis Frey with Council Members Kelsey Timmer, Clyde Schulz, Gary Miller, Loren Daede, David Ripplinger, David Czywczynski and Kathy Kelsch present. Eric Hoffer absent.

BID OPENING

Bid Opening for the Storm Sewer Project which includes two Improvement Districts: STS Dist. $\#2 - 12^{th}$ Street & STS Dist. #3 - Gateway Addition

Schulz moved to close the acceptance of bids. Daede seconded. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor.

Wagner Construction – STS #2 \$405,115.75, #3 \$304,342.92 - \$709,458.67 total base bid Unlimited Excavating – STS #2 \$419,500, #3 \$379,965 - \$799,465 total base bid BEK Consulting – STS #2 \$439,353, #3 \$321,490 - \$760,843 total base bid

Czywczynski moved to accept the low bid from Wagner Construction of \$709,458.67 contingent on the review of bonding. Kelsch seconded. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor.

MINUTES

Schulz moved to dispense with the reading of the minutes of the last regular meeting on May 20 and approve as furnished to the Council by email. Miller seconded. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor.

PUBLIC INPUT

Cindy Zahn of WARC – gaming funds are used for the shortfall of grants that have been cut from the state and federal government. Funds are also used to provide a food pantry. Client intake has increased countywide since last year. Schulz moved to approve the site authorization for WARC at the Nite Owl Bar and the Main Bar July 1, 2019 to June 30, 2020. Timmer seconded. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor.

COUNCIL PORTFOLIOS

Council Member Timmer – The assessment board is in need of another member.

Council Member Kelsch — The Employee Relations Committee has met several times to determine if the city should switch to NDPERS. Currently the plan is through NY Life. There are some plan fees and the employees are required to have life insurance. NDPERS is administered by the legislative body and they can set the return. There are two separate categories: the public employee plan and the public safety plan for law enforcement. If a change is made, existing employees can choose to keep their old plan, but new employees would be required to participate in NDPERS. The committee is recommending to switch to NDPERS. Information will be sent out before the next meeting to summarize the plans. A group life insurance policy and AD&D would also be included with the NDPERS option. Employees could still contribute to a 457b plan through NDPERS, but there would not be a match from the city.

Council Member Czywczynski – Street repairs are taking place.

Council Member Daede – The South Lagoon Lime Removal project is in progress. There was a sewer plug north of Lift #1 in the ravine. It took some effort, but it was cleaned out.

Council Member Schulz – The pool is being filled today. The leak was repaired and the plaster will be put on as the lazy river fills because it cannot dry out.

Council Member Miller – P&Z met on May 16 and the discussion was on lot lines and fences. The church has been moved off the Dollar General lot. Merlin Dahl has resigned from P&Z.

Mayor Frey — NDLC Annual Conference is in September. The Prairie Dog bill was passed. Beulah will receive one million dollars for essential infrastructure. This would be for construction in 2021 on water, sewer or streets. A fund will need to be created to keep the money separate. Budget items will need to be addressed so the preliminary budget can be complete.

CITY PERSONNEL

Economic Development Director — There is a letter of intent regarding the Shopko building. The anticipated closing would be in August if the sale is signed. The Home Rule Charter was discussed with the option to amend it and adopt a full home rule charter. Kelsch moved to amend our current charter to be a full home rule charter. Daede seconded. Information has been sent out to Council regarding the benefits of becoming a full home rule charter city. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor. Century Code requires a committee to be created.

It was discussed that Interstate Engineering could create a citywide corridor plan by putting together all current projects and prioritizing those projects with estimates. Schulz moved to approve the proposal as presented. Czywczynski seconded. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor.

BND Loan option: Our projects are on the SRF list and we are encouraged to apply for funding for the storm sewer project. The BND Loan would cover the remaining portion of the plan that SRF does not cover. Czywczynski moved to proceed with the BND Revolving Loan Fund for the storm sewer project and other projects needed. Miller seconded. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor.

City Engineer – City Wide Street Repair Updates: The concrete crew has been moving through town. Crack sealing is complete.

Quote for Concrete at Dairy Queen Intersection: Czywczynski moved to approve the repair as presented with an estimate of \$37,170. Schulz seconded. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor.

Undermining of Pavement on 2nd Street NW, between 3rd and 4th Ave NW (Jason Fernow residence): The service line went out on the property. Water had been leaking for awhile and a void was created under the driveway as well as under the sidewalk going down the hill.

Manhole lining: The lining of the two remaining manholes north of Lift #1 will start in about two weeks.

City Coordinator – The Beulah Park Board will put together a plan for an access road at the Wellness Center. The Coal Country Clinic is close to completion. Tall grass and dandelions are a problem right now. The Land Use Plan was requested to be sent out again to Council.

City Attorney – Annual Resolution 2019-02 setting the auditor's bond at \$2 million dollars, which is through the ND Bonding Fund. Schulz made a motion to approve Resolution 2019-02 setting the auditor's bond. Daede seconded. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor.

Police Chief – There is a request from the Fire Department to do some landing zone training for helicopters. The Civic Center Parking lot was used last time.

Public Works – The Water Dept. is out flushing sewers and hydrants. Mitchell Mattheis started at the Water Plant last week. Public Works is trying to keep up with mowing.

City Auditor – Special Event Permit for Sportsman's Bottle Shop at the Mercer County Fairgrounds July 11 - 14, 2019. Schulz moved to approve the special event permit as presented. Kelsch seconded. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor.

Kelsch moved to approve the Beulah Lion's Club use of the rodeo grounds again for the demolition derby on August 17, 2019. Schulz seconded. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor.

APPROVAL OF BILLS

Schulz moved to pay the bills as presented. Miller seconded. Roll call vote found Miller, Kelsch, Daede, Timmer, Schulz, Czywczynski and Ripplinger in favor.
