CITY COUNCIL MEETING

The regular meeting of the Beulah City Council was called to order at 7:00 pm by Mayor Travis Frey with Council Members Kelsey Timmer, Clyde Schulz, David Czywczynski, Gary Miller, Kathy Kelsch, and Loren Daede present. Eric Hoffer and David Ripplinger absent.

Kelsch moved to dispense with the reading of the minutes of the last regular meeting on October 21 and approve as furnished to the Council by email. Miller seconded. Roll call vote found Timmer, Schulz, Czywczynski, Miller, Kelsch and Daede in favor.

PUBLIC INPUT

Beulah Rural Fire Protection District

The possibility of a levy for the Rural Fire Protection District was discussed. Kelsch moved to dispense the city allocation of \$20,000 to the Fire Department. Daede seconded. Roll call vote found Timmer, Schulz, Czywczynski, Miller, Kelsch and Daede in favor.

Granville Brinkman

The Home Rule Charter Special Election is tomorrow at the Beulah Civic Center. It was clarified that the Home Rule Charter is a constitution, not a contract and that the City has eminent domain with or without the Charter. Information on sales tax was also clarified. An unofficial count can be released tomorrow after the ballots are counted.

Council Member Kelsch

She attended the Main Street ND Conference. The overwhelming message from the keynote speaker was to make communities more walkable. Topics presented included reaching out to everyone in a new family moving to town, Census 2020 and the importance of completing the census survey, and grant writing and fundraising. If possible, it is important to have a person dedicated to write grants for a city. It was mentioned that the Census will have an online option available.

Council Member Daede

The Water Plant roof leak is being repaired. Moore drafted a letter to Solem Law on the difference of elevation for the Sludge Removal Project.

Council Member Schulz

The Main Street ND Conference was very comprehensive. The individuals from our area who attended would like to get together and then have a public meeting. The enthusiasm was excellent. There are many types of grants available for communities. Coal Conversion Counties meeting was held last week. The Lignite Council presented.
