CITY OF BIG RAPIDS LOW-INCOME HOUSING REHABILITATION MINI-GRANT PROGRAM

The Housing Rehabilitation Mini-Grant Program provides small reimbursement grants of **\$500.00 or less** to low-income City residents to make much needed repairs and improvements to the exterior of their property.

Examples of qualified repairs include:

- siding repair
- exterior painting
- sidewalk repair or replacement
- roof, porch, or window repair



PROGRAM GUIDELINES

- Property must be owner-occupied. Rental properties are not eligible.
- Applicant must reside within the Big Rapids city limits.
- Property owner must meet low-income qualification as determined by HUD Income Limits. (see attached table)
- Project must be for exterior repairs.
- Homeowner must submit an application, photo of structure and area to be repaired, work estimate, and declaration of income.
- Homeowner will receive notification of grant award within 2 weeks of application submission.
- A site inspection must be made by the Community Development Department.
- Project must be completed and receipts of payment along with photo of completed work by **June 14.**
- The Mini-Grant payment will be processed and mailed to homeowner within two weeks of receiving photo of completed work and proof of payment.
- Direct contractor reimbursement or material reimbursement may be possible and will be determined on a case-by case basis. Contact the Community Development Department to discuss your options.



Mini-grants are available on a first-come, first-served basis for owner-occupied properties only. Rental units will not be considered.

Homeowners who have previously received mini-grant funds will be placed on a waitlist to give priorty to first-time applicants.
