





Traffic Crashes and Civil Offenses









USE-OF-FORCE REPORTING TO FBI

The Big Rapids PD began reporting Use of Force incidents to the FBI in 2019, when they began collecting data from law enforcement agencies. The purpose of this collection is to provide nationwide statistics on law enforcement use-of-force incidents.

We realize building trust within our community is key and participating in these efforts allows us to be transparent in how officers interact with members of our community.

The data that is collected is any use of force that results in:

- The death of a person due to law enforcement use of force;
- The serious bodily injury of a person due to law enforcement use of force;
- The discharge of a firearm by law enforcement at or in the direction of a person not otherwise resulting in death or serious bodily injury.

An agency that does not have a qualifying use-of-force incident within the month submits a zero report. Big Rapids has submitted a zero report since implementation.

Firearms qualification and training

Officers participate in close-quarter drills, utilizing cover, precision fire, and low light training scenarios. Officers trained with both handguns and rifles. The department has four (4) firearms instructors on staff.

Policy Review

Law enforcement policies are constantly being updated in response to new state and federal laws and court decisions. We partner with Lexipol for policy, procedure, and daily training bulletins.

- Standard Field Sobriety Test (SFST) & Advanced Roadside Impairment Detection Enforcement (ARIDE) refresher training
 Officers train in OWI detection with the goal of being able to observe, identify, and articulate signs of impairment related to drugs,
 alcohol, or a combination of both in order to reduce the number of impaired driving incidents, injury, and fatal crashes.
- Defensive Tactics and CEW Recertification
- Excited Delirium
- Officer Use of Force
- Duty to Intervene

This focuses on two essential elements—stopping unreasonable force from happening and reporting it afterwards.

- Implicit Bias: Understanding the Impact on Actions & Decisions, Calibrepress
- Officers also attended additional training outside of the department wide training and recertifications.



Big Rapids Police Division Equipment Issuance and Implementation

- Big Rapids Police Division was issued body-worn cameras to promote department transparency and accountability. Each officer was provided with their own body camera to be worn on shift and while interacting with members of the community in an enforcement and investigative capacity. Officers were also trained on department policy and procedure for the use of these cameras.
- Big Rapids Police Division was granted capital improvement funds to purchase much needed equipment in the event of civil unrest. The department's equipment supply in protective helmets had last been purchased in the 1980's. We have upgraded to better fitting and lighter helmets, knee, shin, and elbow guards, protective gloves, polycarbonate shields and batons. Big Rapids Police Division also received an update in field force training.
- Big Rapids Police Division was also issued a supply of personal protection equipment and received a donation of a UV wand for disinfecting equipment and gear due to the Coronavirus pandemic. Officers received daily updates in policy and procedure to coincide with Governor Whitmer's executive orders.
