May 23rd , 2022 Board Meeting Report

May 19, 2022

- Meetings:
 - May 16, 2022, met with representatives of C2AE Engineering who have done water projects for the Township and worked on at least two studies for the creation of two water authority districts. I will be meeting with EGLE staff next week for possible grant fund information and general guidance on water system requirements for connecting our two water systems.
 - May 17th & 18th ; spoke with Gary Jacobsen about him purchasing 441 E Breitung Ave to construct commercial storage buildings.

- Infrastructure
 - Water Projects:
 - Lead Copper service lines on Elizabeth Street, East Kingsford (awaiting sealed bids)
 - Below projects are awaiting engineering completion
 - Replacement of Water main from water tank to Quinnesec Lake Antione Rd.
 - Extension of Water Main on Woodbine and Emmet
 - Water Main extension from Skidmore to M-95 at Boyle

- Zoning / Permits
 - Process requests and furnish information on land use, Environmental history, and zoning regulations of parcels for possible future development.
 - Process applications for: zoning permits, conditional use permits and variances.
 - Signed Zoning Map now posted on our website.

- Grants
 - The Scrap Tire Grant has been signed and accepted by EGLE. I will be meeting again with the new owners of GAD to work out pricing and recycle location/s. The Township may consider fencing in the area west of the Main DPW building to allow for options to have roll offs for spring cleanup, scrap tire collection and a more secure area for stockpiling materials for water projects.

- Additional
 - Work is continuing on the annual Township Audit.
