- Infrastructure
  - Water Projects:
    - Lead Copper service lines on North Elizabeth Street, East Kingsford should be done this week
    - Water Main and other components have been ordered for next years projects to be delivered and stored at the DPW
    - July 26<sup>th</sup> EGLE / USDA Grant funds presentation at Marquette Township provided information and guidance for applying for grants or forgivable loans on upcoming water system projects.
  
  - Bids will have been let for fencing at the DPW with a deadline of August 8<sup>th</sup> at 4:00pm
  
  - Other items for still Parks and Recreation are:
    - Paved walking path around Quinnesec Park
    - A location for a dog park
  
  - The two adjacent landowners of the DNR 40 acres on Old Carney Lake Road that we would have needed a designated easement for unrestricted access to this parcel have both declined allowing any access.
  
  - Cameras and door locks are scheduled to start installation on August 8<sup>th</sup>
  
  - Evaluating the general office layout and use of space and will have more information upcoming.
  
  - Our survey for our Master Plan has been edited to include questions about proposed garbage container changes, the chance to receive a \$100 gas card for participation and reduced in size for ease of mailing to 2,682 refuse account holders. They will be mailed out the first part of this week.
