Do not call now. You are required to contact the office immediately or within 24 hours if you suspect you see bed bug or other vermin in your apartment.

Bed Bug Monitors need to be cleaned on a regular basis

Please be reminded that it is your responsibility to clean and inspect your bed bug monitors on a regular basis. Any bed bugs found in the monitors must be placed in a baggie and brought to the office immediately for inspection.

Winter Reminder

Garden hoses will need to be removed by November 15, 2022, to avoid damage to the water spigot. If you fail to remove your hose and it results in damage to the spigot you will be charged for the repair.
