Scoop Your Poop!

Yes. Your pet's poop IS your poop. Here are some reasons why you should always pick up after your pets:

- One gram of dog waste can contain 23 million fecal bacteria. When pet waste is left on surfaces such as pavement and lawns, it can wash into the storm drains and out to the SF Bay and contaminate water.
- Poop residue can make children or adults who play on contaminated surfaces such as grass sick.
- It's the responsible, decent thing to do!
- It'll make your pets proud of their humans.





WEEKLY CONSTRUCTION UPDATE



Express Lane Project Impacts in Burlingame

Repaving Work: From October 24 through November 13, construction crews will grind and repave the top layer of pavement in the two outside lanes (lanes closest to the freeway shoulder), auxiliary lanes, and freeway ramps from approximately **Broadway in Burlingame** to Grand Avenue in South San Francisco. Additionally, crews will perform this work in the inside lane (closest to the median) from Broadway in Burlingame to Grand Avenue.

Freeway Ramp Closures: Short-term nighttime ramp closures may occur at the Burlingame locations listed below through this weekend.

- Eastbound/Westbound Broadway & Bayshore, Southbound U.S. 101 On-Ramp
- Southbound U.S. 101, Eastbound/Westbound Broadway Off-Ramp (Closures may last until 8:00 a.m. on Saturday, October 30 at this location)

The City of Burlingame is transitioning from at-large elections to district elections. Therefore, instead of voting for all five Council seats, the City will have five districts, and voters will be asked to vote only for the Council seat in their district. To learn more about this transition, go to: www.burlingame.org/districtelections.

On November 1, 2021, from 5:30 p.m. to 7:00 p.m., the City will hold its third public

hearing on the transition. At this meeting, the City's consultant, Redistricting Partners, will review the <u>three draft district maps</u> that they created for the City. These maps were drawn utilizing the 2020 Census data as well as the community of interest forms and citizen maps that community members submitted to the City Clerk. Attend this meeting to ask questions about the maps, give feedback, and help shape the City's future elections.

Additionally, the more feedback the City gets from the community on these maps, the more accurate the district lines will be. Therefore, email your comments on the maps to City Clerk Meaghan Hassel-Shearer at mhasselshearer@burlingame.org.
