2017 Year in Review:

- Planning Commission reviewed all active Conditional Use Permits. Details can be found on the website.
- Wilmar Investments, LLC v. Cascade Township moved into mediation.
- Township hired Assistant Clerk/Treasurer Lois Freed.
- Newly designed township website was launched on August 5, providing many new features including a calendar and the option to sign up for automatic notifications of updates.
- Township picnic was held on August 24 at the Town Hall.
- Planning Commission and Town Board approved one new Conditional Use Permit.
- Cascade Township Canoe Launch on the Zumbro River at the bridge on 75th Street NE opened for public use.
