2022 Year-in-Review:

- Planning Commission reviewed six active Conditional Use Permits and approved one new Conditional Use Permit. Details can be found on the website.
- The revised Cascade Township Planning and Zoning Ordinance was approved, recorded and published.
- Final Plat was approved for Trails of Cascade Phase 2.
- Cascade Township Subordinate Service District infrastructure was installed and activated.
- Annual Cascade Township picnic was held on Wednesday, August 24.

Road maintenance and Snow Removal: Please help our road crew maintain and clear our roadways. **Place your trash containers at the end of your driveway off the road.** With an accumulation of more than 2 inches of snow, vehicles must be removed from the roadway. Thank you!

Storm Water Education: Report to Township Supervisors any illicit discharge and dumping in ditches to help prevent storm water pollution. We are required by state and federal law to establish programs and reporting mechanisms to reduce the discharge of non-storm water and pollutants into our waterways.
